Subject: - F.I.R. regarding commission of an offence u/s 135/ 1 (a) of the Electricity Act 2003 (Amendment Act 2007) against Mr. Rajendra Singh, s/o- Lt. Sibnath Singh, Park Royal, SF Road, PS-Siliguri, Dist-Darjeeling

Sir,

I, Mr Prashanta Kumar Mahato, DE&SM Milanpally CCC, do hereby lodge this complaint to the effect that today (25.08.2025 at 11:45 hours regarding theft of electric energy found during routine inspection by Mr. Bijay Lakra, (s/o- Bernard Lakra), Superintending Engineer (S&LP), Darjeeling Region, Mr. Bhaben Roy, SO (S&LP), Darjeeling Region, Mr Samin Mondal, JE(E) Gr-II and other technical personnel had been to the spot at Park Royal, SF Road.

On physical inspection, it has been detected that said Mr. Rajendra Singh has been using electricity connection for construction purpose by breaking seal of WBSEDCL bus-bar and directly hooking from WBSEDCL network.

He did this intentionally with wrong intention for his wrongful gain.

As Mr. Rajendra Singh has committed an offence, punishable under section 135(1) (a) of Electricity Act, 2003. So, inspection memo and seizure list is prepared by seizing the marble cutting machine and service wire used for construction in presence of witnesses and supplied copies of it to the accused. The connected load is found to be 1.45 kW.
 So, it is requested to start a case u/s 135(1)(a) of Electricity Act 2003 (Amendment Act 2007) against Mr. Rajendra Singh and arrange for its investigation.
