Sir, I Rima Devi, the above noted complainant, lodging the
F.I.R. against above noted alleged persons, stating that on 24-08-2025 at about 07:30 pm, when my son namely Vivek Singh, reached at Mahanda River Bank, Santoshinagar, he saw that some people drinking alcohol in the dark, and when he torn off his mobile flashed light, they chased him and brought him, and started beating him brutally with fist & blunt and when his friend namely, Sharwantha @ Manta S/o Ajit Tha, of Santoshinagar, tried to save my only son, the above noted alleged persons, who were identified by them, hit on him with Beer Bottle and small Sarwantha @ Manta received severe injury on his person, and ^{they} stolen away Rs. 4750/- (Rupees four thousands seven hundred fifty) from my small son, and when my said son & his above noted friend ran away from there, the above noted alleged persons chased them, and they enter into my house behind them and when I tried to stop them, they also attacked on me. at my house, and torn off my clothes & outraged my modesty.

It immediately shifted to Siliguri Distt. Hospital along with Sharwantha @ Manta, & he received primary treatment there. Sir, the above noted alleged persons are very dangerous in nature & they have threatened us to kill. So, please take necessary action against above noted alleged persons
