This is a humble attempt to bring to your august office's notice for death's threat, extortion, theft, illegal restraining of motorcycle, reluctant and illegal approach undertaken by Paridhi Bhagwar, Sudipta Mondal along-with 15 to 20 other persons who introduced themself as an advocate.

Brief facts leading to redress my grievances before you as and by way of my present complaint is stated herein below for the sake of your ready reference and perusal and also to enable you to effectively and efficaciously short out the present matter.

With profound respect and humble submission, I Deep Das, son of Shri Dilip Das, aged about 19 years, resident of South Shanti Nagar, Dabgram - II, Police Station Bhaktinagar, District Jalpaiguri, PIN 734004 in the state of West Bengal. That I am working as godown keeper at Ultratech Cement of Aditya Birla Group situated at opposite to Varsana Hotel, Khaprail Road, Matigara.


That I would like to state you that on 12.08.2025, after finishing my work, at about 8 p.m. I was going towards Khaprail more via Varsana hotel on my motorcycle Royal Enfield Hunter being registration no. WB-73-L-5686 on moderate speed and after traveling to 300 meters of distance suddenly I found that two girls were coming on their scooty being registration no. WB-74-BJ-4267 from Khaparil More towards Varsana Hotel and suddenly they took a turn without showing the indicator and came on the wrong side and due to their

sudden turn and reckless driving their scooty and my motorcycle collided head on hence scooty fell down and along with it the driver also fell down and the entire incident was captured in a CCTV which was installed in a hotel beside the spot. The accident had happened due to the negligent driving of that girl but there were a group of 15 to 20 other person with that girl who were accompanying her with their own vehicles. That girl introduced herself as an advocate and all 15 to 20 persons who were with her had tried to assault me and even pushed me. The girls along with 15 to 20 people started threatening me that the damage done to the scooty will have to be repaired and treatment will also have to be done and started forcing me to get the treatment done at Neotia Get Well only, which is one of the most expensive hospitals in Siliguri. Under the pressure of so many people and to save myself I informed themselves that I belong to a poor family and do a private job as stated above. My salary is only Rs.13,500.00 and I will not be able to get treatment done at Neotia Get Weil. I will get treatment done at some other place and whatever little damage has been caused to the scooty, I will also get it repaired.

The symbol of Advocate Logo was pasted on scooty and Motorcycle, the said picture of the scooty and Motorcycle is shown herein below:

It is need to mention here that no injury is/was caused to that girl/lady and her scooty was also fine and only the front part of the scooty got little damage. However, due to fear of life I agreed and they took me to Anandaloke Multispecialty Hospital, Siliguri along with them at about 10 to 10.30 p.m. along with my mother, aunty and my other well-wisher whom I call on the spot when the miscreants were held me captive and was not letting me to go and demanding money for treatment and repairing of the scooty. That reaching there she was examined by the doctor and doctor after proper examination informed that she is absolutely fine and nothing had happen to her and asked her to go but as they are the powerful people they started to demand illegitimate money, specially the two girls who were on the scooty [WB-74-BJ-4267] who introduce themselves as an advocate and a man namely Sudipta Mondal who introduce himself as the husband of the girl who was driving the scooty namely Ms. Paridhi Bhagwar [Mobile No. 7001399025] was desperate and dangerous in nature they along with their other persons total 15 to 20 in number were present in the said hospital and was not letting us to go to our home and demanded money than they will let us to go or else said Paridhi Bhagwar have threatened in dire consequences that "You don't know what is the power of an advocate. I am a very big and a prominent criminal lawyer of Siliguri court. I will trap you and your entire family by filing a police case against you and will also get money from you". It is pertained to note here that they not only humiliating me but they humiliate my entire family for my caste and poverty those who were present at hospital at that time.

It is pertinent to mention here that as stated above the entire incident was captured in a CCTV installed beside the spot and by seeing the same everything will get clear as such, I requested them to take any decision so that police could investigate and brought the true picture.

That they by showing their muscle power and being an advocate have done wrong to me but after lot of requests at last 12.30 a.m. they let us to go but forcibly they kept/illegally restrained my motor cycle with them and asked me

to come tomorrow with money and then only they will hand over my motorcycle to me.

That they have been illegally detaining my motor cycle since 12.08.2025 and j has been 5 [five] days since the day of incident. They are not returning my vehicle, on the contrary, they call and threaten me to provide the money otherwise they will file a case against me. Neither do they filing a case nor an they returning my vehicle, they repeatedly threatening me that they are the advocate and say that they will ruin my life. They will file so many cases against me that I will have to leave Siliguri, else have to go behind the bar.

That Advocates are the pillar of administration of justice. They are the officers of the court. They facilitate the court in delivering justice to the litigants Dhanraj Singh Choudhary vs. Nathulal Vishwakarmal, the Supreme Cour observed; "The legal profession is a noble profession. It is not a business or a trade. A person practicing law has to practice in the spirit of honesty and not in Applex 17/08/25 the spirit of mischief-mating or money-getting. An advocate's attitude towards and dealings with his client have to be scrupulously honest and fair."

The Supreme Court of India in re Rameshwar Prasad Goyal case on 22.03.2013 viewed that lawyers play an important part in the administration of justice. The profession itself requires the safeguarding of high moral standards.

That I am belonging to the Schedule Caste community Sub-caste NAMASUDRA and Article 46 of the Indian Constitution focuses on promoting the educational and economic interests of "weaker sections," specifically Scheduled Castes (SCs) and Scheduled Tribes (STs), while also protecting from social injustice and exploitation.

The Scheduled Castes and Scheduled Tribes (Prevention of Atrocities) Act, 1989 is at aim to prevent the commission of offences of atrocities against the members of the Scheduled Castes and the Scheduled Tribes and for matters connected therewith or incidental thereto.

r sincerely hope that your August Office would consider my present situation in the light of interests of justice, Compassion and urgency and take necessary steps for the safeguard of my property, family as well as myself and lodge the complaint under appropriate provision/section of The Scheduled Castes and Scheduled Tribes (Prevention of Atrocities) Act, 1989 & The Bharatiya Nyaya Sanhita (BNS), 2023.

If no penal and appropriate lawful action has been initiated against culprits, the said culprits may follow the same modus operendi to do more offences in future with some other person/s who are vulnerable towards action of Police personnel without having appropriate jurisdiction/authority.
