I'm producing herewith 01 (one) accused person namely Sanjay Paul (33 yrs) S/O Ratan Paul of Samar Nagar Auto Stand near Samar Nagar Primary School, PS- Bhakti Nagar, Dist- Jalpaiguri under arrest and the following articles under seizure viz (i) 01 iron made improvised small fire arms measuring approx 23 cm in length including its 8.5 cm iron made pistol grip, having approx 14 cm barrel, trigger, firing pin and firing hammer in proper working condition - Marked as Exhibit 'A' and (ii) 01 (one) live ammunition- Marked as Exhibit - 'B'). I, SI Bandhan Roy of Pradhan Nagar PS, SPC do hereby lodged this written complaint against the above mentioned arrested accused person namely Sanjay Paul (33 yrs) S/O Ratan Paul of Samar Nagar Auto Stand near Samar Nagar Primary School, PS- Bhakti Nagar, Dist- Jalpaiguri to the effect that on 27.08.25 at 23.05 hrs I received a specific secret source information that one person is moving at near Biswadeep Cinema Hall under PS- Pradhan Nagar, dist. Darjeeling with illegal firearms with a view to sell the same to his designed customer or to commit any heinous crime. Accordingly, I diarized the information in PS General Diary vide Pradhan Nagar PS GDE No. 1678 dated 27.08.25 and informed the fact to you.

As per your kind order and direction myself along with ASI Biplab Kr Das, ASI Bikash Roy and force left for Biswadeep Cinema Hall under P.S- Pradhan Nagar, Dist. Darjeeling with an investigation kit to work out the information by Govt. vehicle. Under this circumstance any search warrant or authorization for search cannot be obtained for want of time. So we had to move fast without affording the miscreant the opportunity for the concealment of evidence or facility for his escape. On the way to Biswadeep Cinema hall, I requested night RT Van officer SI Debabrata Khan to come near Biswadeep Cinema hall to accompany us. At around 23.20 hrs we arrived near Biswadeep Cinema Hall and after a while SI Debabrata Kahn arrived there and accompanied us. I requested two independent persons namely (i) Arun Sahani (25 yrs) S/O Upendar Sahani of Rejendra Nagar, Coolipara, Ward No-01, PS- Pradhan Nagar, Dist. Darjeeling and (ii) Raja Sahani (26 yrs), S/O Chunchun Sahani of Reajendra Nagar, Coolipara, Ward No. 01, PS- Pradhan Nagar, Dist. Darjeeling to remain present and act as witness during search and seizure if required upon which they agreed. Then, I contacted my source and as indicated by the source we noticed that one person was standing near Biswadeep Cinema Hall under PS- Pradhan Nagar, Dist. Darjeeling. We cordoned the place from every corner with due care and caution. On seeing police personnel approaching towards him, he tried to flee away from the spot but on hot chase we were able to apprehend him near Biswadeep Cinema Hall under PS- Pradhan Nagar, Dist. Darjeeling. Thereafter, we disclosed our identities as Police personnel (as we were in civil dress for our convenience). On interrogation, he disclosed his identity as noted above. As per source information that he is possessing firearms and ammunition hence immediately, I searched the said detain person and recovered the following articles viz -(i) 01 iron made improvised small fire arms measuring approx 23 cm in length including its 8.5 cm iron made pistol grip, having approx 14 cm barrel, trigger, firing pin and firing hammer in proper working condition and (ii) 01 (one) live ammunition. On demand he failed to produce any document in respect of fireArm and ammunition which was found in his exclusive and conscious possession. Accordingly, I seized the above-mentioned articles from his possession in presence of independent witnesses noted above under proper seizure list and duly signed by the witness and acknowledged by the accused person. The search seizure and label were made in between 00.05 hrs to 00.30 hrs on 28.08.25 at the spot under the coverage of videography as per norms of BNSS. On further interrogation he admitted that he came there to deliver the same to his design customer for his wrongful gain.

Thus, when his involvement in carrying and possessing illegal Firearms and ammunition was established, accordingly I arrested him under proper memo of arrest and observed all the formalities for violating the norms of Arms Act. I informed him regarding grounds of arrest and also issued a copy of memo of arrest and ground of arrest to him.

Under the above noted facts and seizure of incriminating articles, there is strong reason to believe that the said accused person namely Sanjay Paul (33 yrs) S/O Ratan Paul of Samar Nagar Auto Stand near Samar Nagar Primary School, PS- Bhakti Nagar, Dist- Jalpaiguri is desperate and dangerous in nature, as he was carrying the said Fire arm and live ammunition with an objective to sell the same or to commit any heinous crime in the locality. As he wilfully violated the regulation of Arms Act, I, therefore pray before your good self that a specific case may kindly be initiated against the accused person namely Sanjay Paul (33 yrs) S/O Ratan Paul of Samar Nagar Auto Stand near Samar Nagar Primary School, PS- Bhakti Nagar, Dist- Jalpaiguri under proper section of law and may arrange to cause its investigation.
