Respected Sir,

In producing herewith one Tractor with Trolley bearing Reg. number TC/180 loaded with illegal river bed materials seized near Balason Bridge under Matigara PS, Dist. Darjeeling.

I, SI Mrinal Basunia of Matigara PS, Siliguri Police Commissionerate beg to report that on 27.08.25 at 07.55 hrs I along with C/1398 Biswajit Roy and C/154 Mihir Sen both of Matigara PS left the PS to perform morning Q.R.T. Mobile Van duty vide Matigara PS M.C.C. no. 2584, dated 27.08.25 and G.D.E. No-1474 dated 27.08.25. During my petrol duty on 27.08.25 at 10.05 hrs I received a secret source information that some miscreants were removing, loading and selling sand/stone from the Balason river. Accordingly I informed to I/C, Matigara PS over telephone regarding the information in hand who directed me to verify the veracity of the information. As per his kind order and direction myself along with the above noted force rushed to the spot. After reaching near at Balason Bridge found the above noted Tractor Reg. no. TC/180 loaded with river bed materials. On seeing the Police party the driver of the above noted vehicle managed to fled away but we the police party succeeded to intercept the said Tractor and on physical verification found the above noted Tractor loaded with illegal river bed materials. I searched the surrounding area to secure arrest of accused driver but in vain. It is very much evident that driver of the above noted Tractor dealt with the illegal river bed material and the same procured by stolen or fraudulent means and there is sufficient reason to believe that the illegal river bed material loaded in the said Tractor is stolen one. The mining in the Balason river basin is illegal. Accordingly, I seized the Tractor displaying number plate TC/180 loaded with illegal river bed materials after preparing seizure list duly signed by available witnesses and brought to Matigara PS.

Hence, I pray that a specific case under proper section of law may kindly be start against the driver of vehicle no. TC/180 and arrange for its investigation.
