Subject: FIR regarding burglary at my residence on 23rd August, 2025

Through the Officer-in-Charge, Uttarayon Township Police Outpost, Uttarayon, Matigara, Siliguri

Respected Sir,

I, Dr. Asif Iqbal Hussain, son of Lt. Mr. Ahmed Hussain, residing at F Block 23/26, Uttarayon Township, Matigara, Siliguri, West Bengal - 734010, hereby lodge this First Information Report regarding a serious incident of burglary at my residence.

On the night of **23rd August, 2025**, unknown miscreants unlawfully broke into my house, which was unoccupied at the time as my family has recently shifted to Guwahati. The intruders forcibly entered the premises, vandalized the interiors, and ransacked the entire house. They broke open the main entrance door, almirahs, and other locks, leaving the house in a damaged and disorderly condition.

The following items were stolen/destroyed during the incident:

- Bathroom fittings including multiple faucets,
- CCTV cameras and DVR box (either stolen or broken),
- Other household articles, details of which shall be furnished during investigation.

Apart from theft, substantial damage was caused to property including almirahs, doors, and fittings. The gravity of this offence requires immediate attention.

I therefore request you to kindly register this complaint as an **FIR**, initiate a prompt and thorough investigation, and take urgent steps to apprehend the culprits at the earliest. I also seek your assistance in recovering the stolen property and ensuring that such incidents are prevented in future.

I am prepared to extend full cooperation and provide any further details or documents necessary for the investigation.
