With due respect, I am producing herewith the 04 (four) arrested accused persons namely (i) **Barman** (30 yrs), S/o- Late Kartik Ch. Barman of Sishabari, Purba Rangia PS- Matigara, Dist- Darjeeling, (ii) **Dinabandhu Roy** (44), S/o- Birendranath Roy of Moulani, Lataguri, , PS- Malbazar, Dist- Jalpaiguri (At present Bhalobashamore, Ps. NJP, Dist. Jalpaiguri) (iii) **Chandan Mohan Choudhury @ Sajan** (27), S/o- Sikendar Choudhury of B. T. Ranadeep Colony, PS- Matigara, Dist-Darjeeling, (iv) **Sourov Biswas** (24), S/o- Ramprasad Biswas of Bhalobasha More, PS- NJP, Dist- Jalpaiguri and the following articles under seizure :-

1. One iron made Die measuring approximately 02 feet from the possession of accused named Sourov Biswas.
2. One Torch light & one Plier from the possession of accused person named Chandanmohan Choudhury @ Sajan.
3. One iron Sabol measuring approx 1.6 feet and one Hackshaw from the possession of accused person named Nimai Barman 4. One Iron Rod measuring approx 03 feet and one Plier from the possession of accused named Dinabandhu Roy.

I. ASI Dipak Kr. Chhetri of Matigara PS, Siliguri Police Commissionerate beg to state that on 27.08.2025 at 23.30 hrs, received a secret source information that a gang of miscreants were assembled at behind T.I.P.A Hall at Biswas Colony area under Matigara PS, Dist.- Darjeeling with deadly weapons and making preparation for committing dacoity at Matigara Bazar area. Accordingly, I informed the fact to I/C, Matigara PS and as per his kind order myself along with ASI Bikash Roy, C/219 Sanatan Chitrakar, C/868 Sujal Roy, C/523 Sanjit Kundu all are of Matigara PS, Siliguri Police Commissionerate left for T.I.P.A Hall at Biswas Colony, PS- Matigara, Dist.- Darjeeling to work out the information in hand vide Matigara PS GDE No. 1523 Dated- 27.08.2025. At about 23:45 hrs we arrived at behind T.I.P.A Hall at Biswas Colony under Matigara PS. After arrival of the spot and as identified by the source we found that 10/12 persons were assembled beside a river and they were whispering in a very low voice. Accordingly we cordoned the place properly and approach towards them very slowly and carefully. But seeing the police party they started to flee away but we managed to apprehended 04 (four) persons of them. On interrogation, the apprehended accused persons disclosed their name and identity as noted above (not verified) and also disclosed that they assembled there for making preparation for committing dacoity in Matigara Bazar area. They also stated that others 06/08 associates were able to fled away from the spot by taking advantages of darkness and rain. On being searched of the apprehended accused persons, found the above noted articles from their possessions. Accordingly, I seized the above noted articles under proper seizure list and arrested the above noted 04 (four) accused persons under proper memo of arrest and observing all the formalities of arrest. The search seizure was made in between on 27.08.2025 at 23.55 hrs to on 28.08.2025 at 00.07 hrs. The whole process of search & seizure was made under video graph.



Under the above noted fact and circumstance, I therefore pray to you that a specific case under proper section of law may kindly be started against the arrested accused persons namely (i) Nimai Barman (30 yrs), S/o- Late Kartik Ch. Barman of Sishabari, Purba Rangia PS- Matigara, Dist- Darjeeling, (ii) Dinabandhu Roy (44), S/o- Birendranath Roy of Moulani, Lataguri, , PS- Malbazar, Dist- Jalpaiguri ( At present Bhalobashamore, Ps. NJP, Dist. Jalpaiguri) (iii) Chandan Mohan Choudhury @ Sajan (27), S/o- Sikendar Choudhury of B. T. Ranadeep Colony, PS- Matigara, Dist-Darjeeling, (iv) Sourov Biswas (24), S/o- Ramprasad Biswas of Bhalobasha More, PS- NJP, Dist- Jalpaiguri and others and arrange for its investigation.
