Sir,

With due respect and humble submission, I, ASI Utpal Das of Bhorer Alo PS, SPC would like to lodge this written complaint against the arrested accused person namely Sudaru Adhikari (M/ 36 Yrs) S/o- Lt. Gelgelu Adhikari of Ambari Bazar, P.O- Kamarvita, PS- Bhorer Alo, Dist- Jalpaiguri after producing the following seized articles with proper seizure list viz:

(i) Ten (10) sealed Bottles of INDIA MADE LIQUOR 60 up each bottle containing 600ml each style as 'Galaxy Boss' [Total 10 X 600 ml = 6.000 Litres], Rs 160/- each (Amounting of Rs. 160/- X 10 =Rs 1600/-) marked as "Exhibit-A" out of which one bottle is taken as sample and marked as "Exhibit-A-1", to the effect that today on 28.08.2025 at about 04:00 hrs myself along with force while performing my Night PC Van duty under Bhorer Alo Police Station vide Bhorer Alo PS GDE No. 1066 Dated 28.08.2025. During Night PC van duty when we reached at Ambari Bazar, Kamarvita under Bhorer Alo PS area at that time found one person carrying huge quantity of illicit liquor on a nylon bag. Accordingly we apprehended him and on interrogation he stated that the above noted illicit liquor to sell the same at Bhorer Alo PS area.


On further interrogation he stated that he used to sale the 60 up "Galaxy Boss" and 'Galaxy 70 Up Oye Oye' to the owners at different areas under Bhorer Alo Police Station without any valid documents as he violated the norms of Bengal Excise Act for selling the said Liquor without any valid License. On search (i) Ten (10) sealed Bottles of INDIA MADE LIQUOR 60 up each bottle containing 600 ml each style as 'Galaxy Boss' [Total 10 X 600 ml = 6.000 Litres], Rs 160/- each (Amounting of Rs. 160/- X 10 =Rs 1600/) and kept at nylon bag which he was carrying. On being interrogation, he disclosed his name & identity as Sudaru Adhikari (M/ 36 Yrs) S/o- Lt. Gelgelu Adhikari of Ambari Bazar, P.O- Kamarvita, PS- Bhorer Alo, Dist- Jalpaiguri and on further enquiry it could be learnt that he has been involved in selling and possessing of illicit liquor without any valid license since few months for his wrongful gain. The said accused person namely Sudaru Adhikari has violated the norms of Bengal Excise Act. Accordingly Then I, seized and labeled the above mentioned articles under proper seizure list in presence of witnesses and subsequently arrested the above mentioned person namely Sudaru Adhikari after observing all the formalities. The whole process of seizure and label has been made in between 04.35 hrs to 04.45 hrs.

Therefore I pray before your honor that a specific case may kindly be started against the arrested accused lady namely Sudaru Adhikari (M/ 36 Yrs) S/o- Lt. Gelgelu Adhikari of Ambari Bazar, P.O- Kamarvita, PS- Bhorer Alo, Dist- Jalpaiguri along with seized articles under proper section of law and arrange for its investigation.


