I Sujit Kumar, son of Bhikhari Singh, resident of Prakash Nagar, Sahani Basti, Ward No.43, P.O. Sevoke Road, P.S. Bhaktinagar, Dist. Jalpaiguri, Pin- 734001, would like to inform you that on 27/08/2025 at around 8:30 p.m. to 09:00 p.m. my father namely Bhikhari Singh, son of Late Harinath Singh, age about 45 years, resident of Prakash Nagar, Sahani Basti, Ward No.43, P.O. Sevoke Road, P.S. Bhaktinagar, Dist. Jalpaiguri, Pin- 734001, was riding his cycle on the road of Gandhi Nagar More, P.S. Bhaktinagar, Dist. Jalpaiguri. At that time suddenly a speeding Four Wheeler CRETA Hyundai Car being vehicle no. WB02AJ9191 collided from back side with my father's cycle and many other vehicles as well as people on the road. As a result of this accident and because of the rash and negligent driving of the said vehicle my father sustained many injuries on his body and head and also the right leg has been fractured and is admitted in I.C.U. in Anandaloke Hospital and fighting with his life. The accident occurred due to the rash and negligent driving / overspiding / careless behavior of the driver namely Md. Najir of the said vehicle.

Therefore I request you to kindly register this F.I.R., investigate the matter and take necessary legal action against the person responsible.
