

Sir,

In producing herewith one arrested accused person namely Sri Binoy Roy (M-45yrs) s/o Late Bela Charan Roy of Khai Khai Bazar Ektiasal PO, Sevoke road PS- Bhaktinagar, Dist.- Jalpaiguri along with the following articles under proper seizure list: -

[1] 14 (Fourteen) sealed bottles of "HIMALAYAN GOLD" 60 UP PET India Made Liquor each bottle containing 600 ml, i.e. 600 X 14 = 8400 ml, having M.R.P. of Rs. 160/- i.e. 160 X 14 = Rs, 2240/-, bottled by Himalayan Endeavour Pvt. Ltd and is marked as "Exhibit-A" out of which 01 (One) bottle taken as a sample and marked as "Exhibit -A-1".

I, ASI Dinesh Ch Roy S/O Late Madhu Roy of Ashighar OP under Bhaktinagar Police Station Siliguri Police Commissionerate would like to lodge this written complaint against the above-noted arrested accused person namely Sri Binoy Roy (M-45yrs) s/o Late Bela Charan Roy of Khai Khai Bazar Ektiasal PO, Sevoke road PS- Bhaktinagar, Dist.- Jalpaiguri to the effect that on 28.08.25 at around 15.05 hrs. I received a reliable source information that one person is selling illicit liquor in his shop at Dudh more under PS - Bhaktinagar, Dist.- Jalpaiguri without any valid license. Accordingly, the fact is diarized in the General Diary vide Ashighar OP GDE No 916 Dated 28.08.25, and shared the information with O/C Ashighar OP and as per his kind direction, I along with force left for Dudh more to verify the veracity of the information vide GDE NO 916 dtd, 28.08.25. At around 15.15 hrs on reaching there and as identified by the source we cordon the shop and held raid and apprehended the above noted person on being asked he disclosed his identity as mentioned in above also stated that he is selling illicit liquor from his shop without any valid license for his wrongful gain during raid some customers are managed to flee away from the spot. On further search, the above-noted seized articles were recovered from his shop. On-demand he failed to produce any valid license/papers for selling and storing such articles. On further interrogation, Binoy Roy stated that he had been involved in selling and possessing liquor without any valid license for the last few months for his illegal gain. Then, I seized and labeled the above-mentioned liquor under the proper seizure list and arrested Binoy Roy u/s 35 BNSS 2023 after observing all sorts of formalities at the spot to maintain his modesty also inform his ground of arrest. The whole process of seizure and label has been made in between 15.45 hrs to 16.25 hrs the whole process of search and seizure under proper videography.

Under the above-noted fact and circumstances, I, therefore, pray before your good self that a specific case may kindly be initiated against Sri Binoy Roy (M-45yrs) s/o Late Bela Charan Roy of Khai Khai Bazar Ektiasal PO, Sevoke road PS- Bhaktinagar, Dist.- Jalpaiguri under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
