Sir,

In producing herewith one arrested accused person namely Jagabandhu Roy @ Joga-32yrs s/o Madhusudhan Roy of Rangamati, PS Sitalkuchi, Dist Cooch Bihar along with the following seized articles under seizure as per seizure list:

- (i) 15 (Fifteen) Bottles of ONEREEX cough syrup each bottle containing 100 ML having Composition, Chlorpheniramine Maleate IP 04mg, Codeine phosphate IP 10 mg (Total weight 15pcs X100 ML=1500 ML = 1.5 Ltrs) and marked as Exhibit-A
- (ii) 49 (Forty nine) vials of BURENORPHINE injection, 1P 3mg/ml each vial containing with 02 ML ampoule (Total-98 ML) marked as Exhibit-B
- (iii) 47 (Forty seven) vials of PHENERGAN (Pronethazin hydrochloride injection each vial containing with 02 ML (Total-94 ML) and marked as Exhibit-C
- (iv) 49 (Forty nine) vials of DIAZEPAM injection 1P, 5,g each vial contained with 02 ML (total 49x2=98 ML) and marked as Exhibit-D
- (v) One Blue colour HONDA Activa-5g Scooty having Registration No-WB74AY/5145 and Engine No-JF50E-G-0052234
- (vi) One Hero Shakti key pad mobile phone having IMEI No-356923840195252/60 with sim no-7602776522
- (vii) One Reno (Silver & Blue colour) mobile phone vide IMEI No-865865061452694/86 with sim no-8167576476
- (viii) One Black colour bag. (SL no-i to 4 kept in SL no-v)

I, SI Srimanta Chatterjee s/o Lt Debi Prasad Chatterjee of Bhaktinagar PS under Siliguri Police Commissionerate do hereby lodged this written complaint against above mentioned accused person to the effect that on 28.08.25 at about 20.05, received a reliable source input that male person was coming towards Check post from Jaleswari side through Eastern bypass riding a Scooty with huge quantity of illegal cough syrup and injections for delivering the same to his designed customers at Siliguri area for his wrongful gain. The matter was diarized in Bhaktinagar PS vide Bhaktinagar PS GDE No. 1183 dated 28.08.25 and subsequently, I informed the matter in written to the I/C Bhaktinagar PS, SPC and being directed, at about 20.15hrs myself along with SI Yuel Lepcha, ASI Dipak Karmakar, ASI Dhurbo Mishra, ASI Khagen Barman, Const/374 Debraj Biswas, all are Bhaktinagar PS with investigation kit left for Eastern bypass by govt vehicle to verify the veracity of the information also informed PS Van officer ASI Pasang Dawa Sherpa (K-38) with force to come at the spot immediately. This refers to Bhaktinagar PS GDE no. 1184 dated 28.08.25 and M.C.C No- 4295/2025 Dated 28.08.25.

accused person. The whole process of search & seizure has been audio & VDO graphed. The whole process of seizure was made in between 21.10hrs to 22.50hrs.

Being further asked, the apprehend person namely Jagabandhu Roy @ Joga-32yrs s/o Madhusudhan Roy of Rangamati, PS Sitalkuchi, Dist Cooch Bihar admitted in presence of Shri Amit Adhikary, Inspector In-Charge of Bhaktinagar PS and other witnesses that he procured the cough syrup and injections clandestinely from elsewhere for the purpose of selling the same in high rate to his designed customer for his personal gain by illegal means. He also disclosed that he had been dealing in such business of procuring and selling of cough syrup illegally for last few months.

Then, I arrested the above noted accused person namely Jagabandhu Roy @ Joga-32yrs s/o Madhusudhan Roy of Rangamati, PS Sitalkuchi, Dist Cooch Bihar after observing all formalities and informing the ground of their arrest and issued necessary Memo of Arrest u/s 35 (3) of BNSS.

Under the above circumstances, I pray to you that a specific case under proper section of law may kindly be started against the accused person namely Jagabandhu Roy @ Joga-32yrs s/o Madhusudhan Roy of Rangamati, PS Sitalkuchi, Dist Cooch Bihar and arrange for its investigation.

Under this circumstance any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidence or facility for the escape of the offender.

Thereafter at about 20.25hrs we reached at Eastern bypass, near Maldangi, opposite PIAGGIO commercial under Bhaktinagar PS and meanwhile called two independent witnesses namely; (1) Bikki Paul-32yrs (Ph-8016699730) s/o Pradip Paul c/o Sujit Mohanta of Bottle company bazaar, ward No-41, PS Bhaktinagar Dist Jalpaiguri and (2) Prakash Barman-28yrs (Ph-8653854247) s/o Uttam Barman c/o Fagunath Roy of Bottle company more, Pipe Line, ward No-41, PS-Bhaktinagar Dist- Jalpaiguri and disclosed our identity and informed them about the information in hand and requested them in writing to accompany us in the whole process during search and seizure, if any and they gave in writing about their approval to accompany Police during raid, search and seizure. Being accompanied by source and the witnesses our whole police party was waiting at Eastern bypass, near Maldangi, opposite PIAGGIO commercial. After some time we detained one male person with one scooty having Registration No-WB74AY/5145 at Eastern bypass opposite PIAGGIO Commercial. We disclosed our identity and the information in hand and stated him that he along with his scooty will be searched in person for the purpose. At this, he disclose his name and address as noted above and also found one black colour bag in the dicky of his scooty. On being asked he admitted that he had illegally possessed Cough syrup and injection in his possession for selling the same to his designed customers as per requirement for his wrongful gain.

I then gave an option in writing whether will willing to be searched in presence of an Executive Magistrate or Gazette Police Officer, on return he given in written reply that he is willing to be searched in presence of Gazette Police Officer. Then I informed over telephone to Shri Amit Adhikary, Inspector In-Charge, Bhaktinagar Police Station through my personal mobile phone (No-9733284548) to come to Eastern bypass, near Maldangi, opposite PIAGGIO commercial requested him to presence during search and seizure of the Cough syrup and injections. Accordingly at 20.55 hrs Shri Amit Adhikary, Inspector In-Charge, Bhaktinagar Police Station arrived at the spot as Gazette Police Officer and subsequently, under his supervision in presence of witnesses the process of search of the detained person for conducted following all formalities and recovered the above noted articles from the possession of above noted accused person. Subsequently, being demanded in presence of Shri Amit Adhikary, Inspector In-Charge, Gazette Police Officer the detained person failed to produce any valid document in support of possessing of the cough syrup and injections.

Thereafter, I recovered one black colour bag from his scooty having no-WB74AY/5145 which containing with (1) 15 (Fifteen) Bottles of ONEREEX cough syrup each bottle containing 100 ML having Composition, Chlorpheniramine Maleate IP 04mg, Codeine phosphate IP 10 mg (Total weight 15pcs X100 ML=1500 ML = 1.5 Ltrs) (2) 49 (Forty nine) vials of BURENORPHINE injection, 1P 3mg/ml each vial containing with 02 ML ampoule (Total 98 ML (3) 47 (Forty seven) vials of PHENERGAN (Pronethazin hydrochloride injection each vial containing with 02 ML Total-94 ML (4) 49 (Forty nine) vials of DIAZEPAM injection 1P, 5,g each vial contained with 02 ML total 49x2=98 ML which was kept inside in above noted scooty. Then, I seized the above noted articles at the spot under proper seizure list duly signed by the independent witnesses. I also labelled and sealed all the articles under the supervision of Shri Amit Adhikary, Inspector In-Charge of Bhaktinagar PS and witnesses and
