Sir,

With due respect, I am producing herewith one accused person namely Shibu Paul (32 yrs) S/O Late Buddhadeb Paul of South Ambedkar Colony, Ward No-01, PS- Pradhan Nagar, Dist.- Darjeeling under arrest and the following seized articles viz :-

- (i) One paper made cortoon containing 12 (twelve) bottles of "IMPERIAL BLUE" Superior Grain Whisky each bottle containining 750 ml i.e. total (12 x 750 ml = 9 ltrs) -Marked as Exhibit "A" out of which one bottle of the same taken as sample for examination and Marked as exhibit "A1".
- (ii) One paper made cortoon containing 12 (twelve) bottles of "ROYAL CASTLE" Blue Premium Whisky each bottle containing 750 ml i.e. total (12 x 750 ml = 9 ltrs) -Marked as Exhibit "B" out of which one bottle of the same taken as sample for examination and Marked as exhibit "B1".
- (iii) One paper made cortoon containing 12 (twelve) bottles of "MAGIC MOMENTS" Grain Vodka each bottle containining 750 ml i.e. total (12 x 750 ml = 9 ltrs) -Marked as Exhibit "C" out of which one bottle of the same taken as sample for examination and Marked as exhibit "C1".
- (iv) One paper made cortoon containing 12 (twelve) bottles of "MAGIC MOMENTS" Grain Vodka each bottle containining 750 ml i.e. total (12 x 750 ml = 9 ltrs) -Marked as Exhibit "D" out of which one bottle of the same taken as sample for examination and Marked as exhibit "D1".

I ASI Prabal Sarkar of Pradhan Nagar PS, SPC do hereby lodged this written complaint against the above noted arrested accused person namely Shibu Paul (32 yrs) S/O Late Buddhadeb Paul of South Ambedkar Colony, Ward No-01, PS- Pradhan Nagar, Dist.- Darjeeling to the effect that on 28.08.2025 at 00.35 hrs. I received source information that one person would be come to Siliguri Junction near SNT under PS- Pradhan Nagar, Dist. - Darjeeling with huge quantity of illicit liquor with a view to deliver the same to his design customers at Siliguri Junction area for his wrongful gain. Accordingly, I diarized the fact in PS General Diary vide Pradhan Nagar PS GDE No. 1681 dated 28.08.2025 and informed the matter to you. As per your kind order and direction, I along with SI Rajiv Subba, ASI Bikash Roy and force all of Pradhan Nagar PS left for Siliguri Junction near SNT by Govt vehicle with investigation kit to verify the veracity of the information. On the way to Siliguri Junction, I requested night RT van officer SI Debabrata Khan to come to Siliguri Junction near SNT to accompany with us. At around 00.55 hrs we arrived at Siliguri Junction near SNT and after a while night RT van officer SI Debabrata Khan and force arrived at near SNT and accompanied with us. Then I contacted with my source and being identified and shown by the source, I noticed that one person was standing at near SNT, Siliguri Junction with four paper made cartoons in his possession. Then I cordoned the place from every corner with due care and caution and managed to detain him with four paper made cartoons in his possession. On interrogation he disclosed his identity as noted above and on searched all the four cartoons in his possession we recovered the above noted articles from his possission. On demand he failed to produce any documents in respect liquor recovered from his possession. During local enquiry it could be revealed that the detained person namely Shibu Paul (32 yrs) S/O Late Buddhadeb Paul of South Ambedkar Colony, Ward No-01, PS- Pradhan Nagar, Dist.- Darjeeling is running such type of illegal business of selling illicit liquor without any valid documents for his wrongful gain. As the accused person namely Shibu Paul (32 yrs) S/O Late Buddhadeb Paul of South Ambedkar Colony, Ward No-01, PS- Pradhan Nagar, Dist.- Darjeeling has violated the norms of Bengal Excise Act, Hence, I seized the above noted articles under proper seizure list in presence of witnesses and arrested him under proper memo of arrest and after informing him regarding ground of his arrest and brought to the Pradhannagar PS to proceed further investigation. The entire process of search and seizure was made under the coverage of video graphy in between 01.10 hrs to 01.45 hrs at the spot as per norms of BNSS.

Therefore, I pray before your good self that a specific case may kindly be initiated against the accused person namely Shibu Paul (32 yrs) S/O Late Buddhadeb Paul of South Ambedkar Colony, Ward No-01, PS- Pradhan Nagar, Dist.- Darjeeling under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
