Dear Sir,

I, Sri Abhishek Roy, S/O Jagadish Ch Roy, Station Manager, Customer Care Centre Matigara, WBSEDCL , P.S Matigara do here by lodge this complain empowered by Electricity ACT 2003 (amendment act 2007) to the effect that Lalji Prasad ,S/O Late Surajnath Prasad resident of Salbari, PO Sukna, PS Pradhan Nagar, Darjeeling consumer ID : 412135443 (Previous user Late Surajnath Prasad ) , he has committed use of electricity illegally under section 138 (1) (b),135(1)(e) of electricity Act 2003.

On dated 28.08.25 at 13:42 hr I along with accompanying WBSEDCL team viz. 1) Bhaben Roy S.O S&LP of Darjeeling Regional Office, WBSEDCL, 2) Bijay Lakra, SE & S&LP Darjeeling Regional Office, WBSEDCL 3) Patilal Rai , JE (O) of Matigara CCC, 4) Pradip Biswas of Matigara CCC have entered the premise of Lalji Prasad, Salbari, Under Pradhan Nagar P.S. During inspection it has been found that electricity outstanding bill is present at the premises. It is also found that said connection under con id : 412135443 was disconnected for not paying electricity bill . At the time of inspection it came to our notice that said disconnected line has been reconnected illegally without clearing outstanding dues and also commercial use for godown purpose from this domestic connection meter. Accessed load of electricity illegally enjoyed by him is 2.86 KW. The findings are incorporated in the inspection report prepared at site.

Hence prepare an inspection memo by mentioning all minute details , as observed and also seized the meter in question after preparing the proper serial list duly signed by witnesses and representative of the premise owner. Supply copies of required documents to the representative for future reference. Remove the meter from the place after observing all technical formalities.

The inspection team left the said premises at 14:00 hrs on date.

So it is requested that a case under section 138 (1) (b), 135(1)(e) of Electricity Act may please be registered against Lalji Prasad ,S/O Late Surajnath Prasad and arrange for its investigation.
