During inspection it has been found that electricity outstanding bill is present at the premises. It is also found that said connection under con id: 412135443 was disconnected for not paying electricity bill . At the time of inspection it came to our notice that said disconnected line has been reconnected illegally without clearing outstanding dues and also commercial use for godown purpose from this domestic connection meter.
