I, Sri Abhishek Roy, S/O Jagadish Ch Roy, Station Manager, Customer Care Centre Matigara, WBSEDCL, P.S Matigara do here by lodge this complain empowered by Electricity ACT 2003 (amendment act 2007) to the effect that Sushant Bhusal S/O Tek Bahadur Bhusal resident of R N Singha Road, Dr Zakir Hussain Busti , PO & PS Darjeeling consumer ID : 402635530 (Previous user : Chhanu Roy) , he has committed use of electricity illegally under section 138 (1) (b) of electricity Act 2003.

On dated 28.08.25 at 12:42 hr I along with accompanying WBSEDCL team viz. 1) Bhaben Roy S.O S&LP of Darjeeling Regional Office, WBSEDCL, 2) Bijay Lakra, SE & S&LP Darjeeling Regional Office, WBSEDCL 3) Patilal Rai , JE (O) of Matigara CCC, 4) Pradip Biswas of Matigara CCC have entered the premise of Bastab Apartment, Salbari, Under Pradhan Nagar P.S. During inspection it has been found that electricity outstanding bill is present at the premises. It is also found that said connection under con id : 402635530 was disconnected for not paying electricity bill on 29.05.2025. At the time of inspection it came to our notice that said disconnected line has been reconnected illegally without clearing outstanding dues. Accessed load of electricity illegally enjoyed by him is 3.064 KW. The findings are incorporated in the inspection report prepared at site.

Hence prepare an inspection memo by mentioning all minute details , as observed and also seized the meter in question after preparing the proper serial list duly signed by witnesses and representative of the premise owner. Supply copies of required documents to the representative for future reference. Remove the meter from the place after observing all technical formalities.

The inspection team left the said premises at 13:15 hrs on date.

So it is requested that a case under section 138 (1) (b) of Electricity Act may please be registered against Sushant Bhusal S/O Tek Bahadur Bhusal and arrange for its investigation.
