In producing herewith one arrested person who disclosed his identities namely Md Bappa (23/M) S/O Md Rafikul of Tikiapara, Mazdoor Colony, Ward No. 28, PS- Siliguri, Dist-Darjeeling along with the seized articles as per seizure list;

(1)One improvised one shutter iron made fire arms measuring approx 24 inches from

barrel to butt having striking pin, hammer and trigger marked as Exhibits- 'A'

(2)One live ammunition engraved O.K 04 unreadable on its percussion cap (found loaded in SI No.1 ) seized from exclusive and conscious possession of accused Md Bappa

(3)One live ammunition engraved O.K 04 unreadable on its percussion cap (which was marked as Exhibits- 'A1' kept concealed in the right pocket of pant of accused Md Bappa) seized from exclusive and conscious possession of accused Md Bappa, marked as Exhibits-A2

I, Uday Chakraborty of Siliguri Police Station, Siliguri Police Commissionerate do hereby lodge this complaint against Md Bappa (23/M) S/O Md Rafikul of Tikiapara, Mazdoor Colony, Ward No. 28, PS- Siliguri, Dist- Darjeeling that on 28.08.25 around 20.05 hrs, received a secret source information that one veteran criminal under Siliguri PS, Dist- Darjeeling namely Md Bappa is roaming at P & T Goli near Gov Housing, Milapally, Ward No, 25 under Siliguri PS with an ulterior motive and is in possession of firearms. Diarised the mater vide Siliguri PS GD Entry No. 1363 dated 28.08.25. As per your kind instruction of I/C Siliguri PS, I along with ASI Debasish Das, ASI Rabin Lama, C/160 Soumen Sarkar all Siliguri PS rushed to the place at P & T Goli near Gov Housing, Milapally, Ward No, 25 under Siliguri PS to verify the veracity of this information vide Siliguri PS G.D.E no.1364 dated 28.08.2025 at 20.15 hrs. Before reaching PO I picked up two disinterested witnesses namely (i) Karan Das (30) S/O Sri Tarun Das of Subhashpally, Lichubagan, Ward No. 18, PS- Siliguri, Dist- Darjeeling and (ii) Rahul Dutta S/O Latye Duipak Dutta of do duly informing them about the information in hand. At 20.25 hrs we reached at nearby P & T Goli near Gov Housing, Milapally, Ward No, 25 under Siliguri PS PS and as per description of the wearing apparels supplied by the source, at 20.30 hrs we found that the above noted person is moving suspiciously at P & T Goli near Gov Housing, Milapally, Ward No, 25 under Siliguri PS. On seeing the police party he tried to escape from the place. But we apprehended the above noted person namely Md Bappa. On being asked, the apprehended person disclosed his identity as noted above. On further interrogation he admitted that he was in the P & T Goli near Gov Housing, Milapally, Ward No, 25 under Siliguri PS with an ulterior motive with illegal Fire Arms. Accordingly, as per information and following all necessary procedures of search of the police person by the witnesses, search of the apprehended person Md Bappa was made on search and found that (1)One improvised one shutter iron made fire arms measuring approx 24 inches from barrel to butt having striking pin, hammer and trigger marked as Exhibits- 'A' (2)One live ammunition engraved O.K 04 unreadable on its percussion cap (found loaded in SI No.1) seized from exclusive and conscious possession of accused Md Bappa marked as Exhibits- 'A1', (3)One live ammunition engraved O.K 04 unreadable on its percussion cap (which was kept concealed in the right pocket of pant of accused Md Bappa) seized from exclusive and conscious possession of accused Md Bappa, marked as Exhibits-A2. The ammunition was unloaded from the firearms and as per practical experience. On being asked about the possession of the firearms and ammunition, the apprehended Md Bappa made incoherent statements and failed to produce any valid documents in support of said seized Firearms. As there is every reason to believe any valid documents in support of said seized Firearms.
