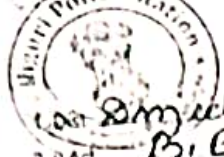

In producing herewith one arrested accused person namely Sarju Pradhan @ Sandy (M/ 21 Years) S/O Sanjay Pradhan of Vivekananda Road, Red Light Area, Khalpara, Ward No. 07 of SMC, P.S- Siliguri, Dist.- Darjeeling along with the following seized articles as per proper seizure list:

1. Total 10 (ten) bottles of Himalayan Gold 60 UP Country Spirit , each bottle containing 375 ml, total 3750 ml. / 3.75 L.
2. One Green Coloured Plastic Bag

I, SI Chiranjit Saha of Khalpara TOP under Siliguri Police Station do here by lodged a written complaint against the above noted accused person named Sarju Pradhan @ Sandy (M/ 21 Years) S/O Sanjay Pradhan of Vivekananda Road, Red Light Area, Khalpara, Ward No. 07 of SMC, P.S- Siliguri, Dist.- Darjeeling to the effect that today on 28.08.2025 at 22.15 hrs. I received a credible source information that one person is selling huge quantity of liquor/ alcohol at Gur Gali area, M.R Compound under Siliguri Police Station in higher price than the actual value for his wrongful gain without any documents/license. The fact was diarized in Khalpara TOP-II under Siliguri P.S GDE No. 791 Dtd. 28.08.2025. Subsequently, after sharing the information with my superiors and as per their direction, myself along with force of Khalpara TOP left for the place to work out the information. This refers Khalpara TOP-II under Siliguri Police Station GDE No-792 Dated-28.08.2025.

We reached at the spot at 22.45 hrs. and on being identified by the source our police party able to apprehend the above mentioned accused person with a green colour plastic bag at Gur Gali, M.R Road Compound under Siliguri Police Station and recovered the above noted articles i.e Total 10 (ten) bottles of Himalayan Gold 60 UP Country Spirit , each bottle containing 375 ml, total 3750 ml. / 3.75 L - inside the green colour plastic bag - from his possession. During local enquiry it came to learn that he is selling the liquor/ alcohol in open market at Gur Gali, M. R Road Compound area since long for his wrongful gain without any valid documents/license. Accordingly, I seized the above noted articles from his possession after preparing proper seizure list in presence of available witnesses and arrested him after maintain all formalities in presence of witnesses. The seizure was made on 28.08.2025 in between 23.10 hrs. to 23.25 hrs. under videography.

Under the above circumstances, I request you to start a specific case may kindly be started against the accused person namely Sarju Pradhan @ Sandy (M/ 21 Years) S/O Sanjay Pradhan of Vivekananda Road, Red Light Area, Khalpara, Ward No. 07 of SMC, P.S- Siliguri, Dist.- Darjeeling under proper section of law and arrange for investigation.
