Sub: Illegal attempt to grab my land violating the injunction order by organized crime syndicate for obtain their illegal financial benefit.

Madam / Sir,

With due respect I Sri Biswajit Paul, S/o Late Biswanth Paul of Bidhan Pally, P.O. & P.S. Mathabhanga, Dist. Coochbehar, would like to inform you that I purchased a piece of land measuring 2 Katha 2 Chattak within specific boundary from one Sri Chitra Singha, S/o Biman Singha, resident of Kawakhali, Medical Collage More, P.O. Sushruta nagar, Police station – Matigara, Dist- Darjeeling by virtue of Registered deed of Sale which was executed by said Chitra Singha on 7th day of December-2005 and the same is recorded in Book No I, Vol No. 168, Page No 381 to 388 Being document No. 6808 for the year 2006 which is fully described in the scheduled below and since then I have been enjoying possession the said land having absolute right, title and interest therein free from all encumbrances and charges whatsoever.

That from June 2024 some person namely 1) Sri Haren Barman, S/o Not known, 2) Mr Ujjal Bhaduri( Puchi), S/o Late Khokan Bhaduri, 3) Mrs. Doli Ghosh, W/o late Uttam Ghosh and 4) Mr. Mithu Saha S/o Not Known have joined their hands to grab my land without having any right over my below schedule land.

Then I lodged complaint against them at NBMC&H Police Out Post Station under Matigara P.S on 02.07.2024 and specific case was started against them being Matigara P.S. Case No. 407/2024.

That thereafter Smt. Doli Ghosh, W /o late Uttam Kumar Ghosh and his son Master Atanu Ghosh S/o late Uttam Kumar Ghosh had filed a false case against me being Title Suit No. 191/2024 before the Ld. Civil Judge (Jr. Division) at Siliguri and Ld. Court after hearing the interim injunction petition pass an order in the following effect;

"Both the parties are directed not to change the nature, character and possession of the suit property as it is" and said order is extended till 25/09/2025.

I appear before the Ld. Court through lawyer and filed WS WITH COUNTER CLAIM against the false claim of the Plaintiff W.O against the injunction petition of plaintiff, I also filed separate injunction petition against the plaintiff.

That thereafter Smt. Doli Ghosh, W /o late Uttam Kumar Ghosh and his son Master Atanu Ghosh S/o late Uttam Kumar Ghosh under instigation of above name person had violate the order of the Ld. Court and started construction of the boundary wall around the suit land and

installed a tin gate in front of the land. Thereafter, I again lodge a complaint at NBMC & H Police Out Post Station under Matigara P.S vide GD E No. 73 dated 03/11/2024.

I like to inform you that one Baijnath Bhagat, S/o Nanku Bhagat, during his life time sold 50 kathas of land for valuable consideration to Sri Gopal Chandra Ghosh, S/o Santosh Kr. Ghosh by virtue of registered deed of sale being deed No. 2270 dated 08.03.1991 registered at Sub - Register Siliguri entered in Book No. 1 Volume No. 53 Page 66 to 70 and got possession of the land within specific boundary.

Thereafter, said Sri Gopal Chandra Ghosh, S/o Santosh Kr. Ghosh sold 5 kathas of land, for valuable consideration in favour of one Smt. Bulu Pradhan, W/o Sri Anupam Kumar Pradhan being sale deed No. 6273 of 1991 registered in the office of Sub - Register Siliguri recorded in Book No. I Volume No. 111 Page 9 to 12 for the year 1991 and got possession thereof within specific boundary.

Thereafter Smt. Bulu Pradhan, W/o Sri Anupam Kumar Pradhan, sold 2 Katha 3 Chattak land out of her 5 kathas land for valuable consideration within specific boundary to one Sri Chitra Singh S/o Benan Sing by virtue of deed of sale being sale deed No. 7847registered in the office of Sub - Register Siliguri recorded in Book No. I Volume No. 129Page 207 to 212 for the year 1991 and got possession thereof within specific boundary from said Chitra Singh S/o Benan Sing I purchase below schedule land for valuable consideration within specific boundary as mentioned in para No. 1.

That from last part of July 2025 since 26.08.2025 some organized crime syndicate member namely (1) Nilatpal Sarkar (Bappa), S/o Late Dilip Sarkar, resident of Thiknikata, Post Office Sushrutanagar, Police Station Matigara, District Darieeling 2) Smt. Sumontri Bhagat 3) Sri Kanai Bhagat and 4) Sri Shyam Bhagat all are wife and son of late Baijnath Bhagat resident of Sukanta Sarani, Ward No. 26 of S.M.C., Post Office Siliguri Bazar, Police Station Siliguri, District Darjeeling 5) Mithu Saha, Son of Late Dulal Saha, C/o. Kailash Bhagat of Thiknikata, Post Office Sushrutanagar, Police Station Matigara, District Darjeeling, 6) Swapan Sen, Son of Late Anup Kumar Sen of Bidhan Pally, Shivmandir, Post Office Kadamtala, Police Station Matigara, District Darjeeling, 7) Manojit Dey (Bula), Son of not known of Thiknikata, Post Office Kadamtala, Police Station Matigara, District Darieeling, they try to grab my below scheduled land violating the Injunction Order of Ld. Civil Judge Junior Division, on the strength of some foreged documents by use of threat of violence, criminal intimidation and by other unlawful means for obtain their direct financial benefit, they also demanded 10 lakhs from me, ignoring my law full right, title and interest over my below scheduled land, they have several times illegally attempt to trespass of my land and illegally attempt to construct over my land violating the Order of Ld. Court for their illegal monetary gain . Whenever I try to restrain them from their illegal activities they become furious and threat me in dire consequences they also warn me that they any how grab my land by any means, so I apprehension of danger of loss of my life and my property by illegal means by the above named persons.

It is pertinent to mentioned here that the above named person are habitual organize land grabbing syndicate in the locality who grave the land of several persons by illegal means by use of threat, violence, criminal intimidation for their illegal monitory gain. There was several cases pending against them, such as Matigara PS case No. 481/24 dt. 08/07/24 U/S 329(3)/324(3)/223/336(2)/(3)/340(2)/3(5) NBS and Matigara PS case No. 694/24 dt. 23/11/24 U/S 316(2)/318(4)/61(2) of BNS

So. I humbly request you take immediate legal action against all above named syndicate members so that they can honour the law of land and restrain them for illegally grab my land by illegal means for their illegal gain, without any lawful order from Competent Court of Law and maintain peace in the locality & save my life and do the needful, your prompt and proper action in this regard is highly solicited.
