D 28.8.35 In producing herewith the 01 (one) arrested accused person namely Ananda Biswas maneral accused person namely approx), S/O- Lt. Nikhil Biswas of Simultola near I.T. Park, PS- Matigara, Dist- Darjeeling (not patigate) Police Station Siliguri Police Commissionerali along with the following seized article under proper seizure list :-

- (i) Twenty (20) no bottle of PHENSEDYL cough syrup having composition Triprolidine Hydrochloride and Codeine Phosphate bearing Mfg Dt- NOV-23 and Expiry Dt- JAN-25, MRP Rs-205.48/- each bottle contain 100 ml and marked as 'Exhibit-A'.
- (ii) One bag pack (Brownish red and black colored) having two compartments styled as MEOW containing Ex-A and marked as 'Exhibit-B'.

I, PSI Avijit Banik, of Matigara Police Station, Siliguri Police Commissionerate do here by lodge this written complaint to the effect that on 28.08.2025 at about 14:35 hrs, received a specific information provided by a credible source that 01 (one) person is standing at Goyel More near Gulmohar, under Matigara PS jurisdiction with a huge quantity of cough syrup for dealing.

Hence, there was a strong reason to believe that there is every chance of committing a cognizable offence under NDPS Act and to check the veracity of information, I reduced the information in writing vide Matigara PS GDE No. 1562, Dated 28.08.2025 and I intimated the information to Shri Arindam Bhattacharjee, I/C Matigara PS, SPC who brought the information to the superior and after obtaining necessary order at about 14:50 hrs myself, along with a team of Matigara PS, SPC consisting of ASI Dipak Kr. Chhetri, ASI Bikash Roy, C/868 Sujal Roy, C/523 Sanit Kundu all are of Matigara PS, SPC took departure vide C.C. No- 2600/25 dated 28.08.2025 from Matigara PS, SPC for Goyel More near Gulmoar under Matigara PS with investigation kit containing wrapping cloth, envelope, white paper, sealing wax, gum, seal, digital weighing machine and other investigation kits by a Govt. vehicle to work out the information and the same was diarized vide Matigara PS GDE No. 1564, dated-28.08.2025.

At the same time I also informed the videographer namely Somnath Chatarjee, S/O- Sushil Chatarjee of Aurobindo Pally, Gokhel Road, W/No. 22, PS- Siliguri, Dist- Darjeeling to be present at Goyel More near Gulmohar, under Matigara PS, SPC to prepare the video of whole process ofsearch and seizure if any. On 28.08.2025 at about 15:05 hrs, we reached at Goyel More under Matigara PS and I met with my source and he briefed me about the detail information and told me that the suspected person is standing near Gulmohar near the gate of Nischintapur Tea Estate with a bag pack in his back. I also looked up for public witnesses to the entire process of search and seizure. I told so many people but two of them expressed their willingness to be present as witness in the process of search and seizure. I also briefed the public witnesses regarding the information in hand. The particulars of the witnesses are as follows- 1] Palash Dhali (25 yrs), S/O- Gopal Dhali of Simultola, PS- Matigara, Dist-Darjeeling and 2] Dipen Barman (33 yrs), S/O- Lt. Satyen Barman of Himul Nagurujote, PS- Matigara, Dist- Darjeeling. Accordingly we proceeding towards the suspected person.

In the meanwhile, I/C, Matigara PS sent a message to SDO, Siliguri to depute an Executive Magistrate during search & seizure of NDPS substances as per norms vide ORG No. 2735/25, Dated-28.08.2025. But after a telephonic conversation, it came to know that due engage in other duty and short notice, there are no Executive Magistrate available to perform the duty.

In the above circumstances and the gravity of the information, if any delay occurred, the accused person may escape. Hence, as per order of superior, I/C, Matigara PS directed Shri Sajal Roy, Inspector of Police, Officer in Charge of NBMC OP under Matigara PS, SPC to be present at the place of occurrence to supervise the search & seizure if any. Accordingly Shri Sajal Roy left for the place of occurrence.

Thereafter we parked our vehicle in a considerable distance and at about 15:20 hrs, my source identified the suspected person who is standing near Gulmohar near the gate of Nischintapur T.E with a bag pack. After a hot chase we managed to apprehend the suspected person. I introduced myself and the raid team members as Police officers. On interrogation he disclosed his name and address as mentioned above. I appraised him about the information in hand that he had in his possession of huge quantity of illegal cough syrup on his belongings and that we intended to search him and the bag he was carrying. Initially he denied having any cough syrup with him and that the bag contained other articles. But I told him that we would search his person and the bag he was carrying. Eventually he admitted that the bag contains cough syrup and he was waiting for his customer to deliver the same.

As per provisions of section 50 of the NDPS Act, 1985 (as amended) I explained to the above noted detained person that he has the legal right to tender his personal search and his belongings in front of an Executive Magistrate or a Gazetted Officer and the same was given to him in writing. In reply he wanted to be searched before any police officer and did not want to search the police team.

At about 15:50 hrs Shri Sajal Roy, O/C NBMC OP under Matigara PS in the rank of Inspector of Police arrived at the spot as a Gazetted Officer where I briefed him the information in a nutshell. On further interrogation, the detained person confessed in front of the Gazetted officer that he was in conscious possession of a huge quantity of illegal cough syrup which was kept at the bag kept with him.

Thereafter, in presence of the Gazetted officer, searched the detained person namely Ananda Biswas. During the search nothing was recovered from his person except wearing apparels. Then I searched the bag pack which he was carrying and found PHENSEDYL cough syrup having composition Triprolidine Hydrochloride and Codeine Phosphate bearing Mfg Dt- NOV-23 and Expiry Dt- JAN-25, MRP Rs- 205.48/- each bottle contain 100 ml.

On interrogation, he stated that he brought the illegal cough syrup from Siliguri to deliver his designated customer. Then, I asked him to produce the valid license/ documents for carrying and possessing the huge quantity of illegal narcotics contraband articles but he failed to produce any legal papers.

After counting it was found that the bag pack (Brownish red and black colored) having two compartments styled as MEOW which was carried by the detained person containing twenty (20) no bottle of PHENSEDYL cough syrup having composition Triprolidine Hydrochloride and Codeine Phosphate bearing Mfg Dt- NOV-23 and Expiry Dt- JAN-25, MRP Rs- 205.48/- each bottle contain 100 ml. Thus, a reasonable belief having been formed that an offence has been committed in contravention of the NDPS Act and that recovered articles were liable to be confiscated by the NDPS Act. Accordingly, I had seized the above noted articles under proper seizure list duly-prepared by me in presence witnesses and Sri. Sajal Roy inspector of police, O/C NBMC OP under Matigara PS, Siliguri Police Commissionerate who acted as Gazetted officer. I also took signatures of the witnesses, the accused person and Gazetted officer and submitted my signature as seizing officer. Copy of the seizure list was given to the detained person.

Thereafter, Twenty (20) no bottle of PHENSEDYL cough syrup having composition Triprolidine Hydrochloride and Codeine Phosphate bearing Mfg Dt- NOV-23 and Expiry Dt- JAN-25, MRP Rs-205.48/- each bottle contain 100 ml have been properly packed and marked as Exhibit-A and labeled and the bag pack (Brownish red and black colored) having two compartments styled as MEOW containing Ex-A and marked as 'Exhibit-B'. Took signature of witnesses and accused person in the label in presence of the Gazetted officer.

PSI Avijil Bann. 28/08/25. I then arrested the above noted accused after informing him the grounds of arrest for the possession and carrying of contraband Narcotic substances under the NDPS Act and issued an arrest memo to him accordingly, duly signed by the accused and witness.

The entire process of Search, seizure, Label, Seal and arrest were done on 28.08.2025 in between 15:55 hrs to 16:50 hrs. The entire process of search, seizure, sealed and labeled was done under the supervision of Sri. Sajal Roy, Inspector of Police, O/C NBMC OP under Matigara PS, Siliguri Police Commissionerate acted as Gazetted officer and video graphed of search and seizure conducted through the camera of Somnath Chatarjee, S/O- Sushil Chatarjee of Aurobindo Pally, Gokhel Road, W/No. 22, PS- Siliguri, Dist- Darjeeling in compliance with the Order of Hon'ble High Court, Kolkata.

Under the above noted fact and circumstances you are requested to kindly lodge a FIR under proper section of law and arrange for its investigation against accused person namely Ananda Biswas (28 yrs approx), S/O- Lt. Nikhil Biswas of Simultola near I.T Park, PS- Matigara, Dist- Darjeeling (not verified) and others involved in this racket.
