In producing herewith One (01) accused person namely Md. Lalan (27 yrs) S/O Lt. Md. Mojim of Tulshi Nagar, PS Matigara, Dist Darjeeling under arrest along with the following seizure articles viz: One (01) black Colour bag pack styled as "adidas" Containing 36 (thirty six) bottles of Codeine Phosphate & Triprolidine HCL Syrup "ANNIREX" Cough syrup each bottle containing 100 ml. i,e total (36 X 100 ml= 3600 ml) having batch No NLF0115, Mfg date 06/25, Exp date 05/27, MRP Rs 175.00 (each bottle) Marked as Exhibit- "A". I, SI Goutam Mallik S/O Late Nikhil Ranjan Mallik of Pradhan Nagar PS, Siliguri Police Commissionerate do hereby lodged this written complaint against the above noted one (01) arrested accused person namely Md Lalan (27 yrs) S/O Lt. Md. Mojim of Tulshi Nagar, PS Matigara, Dist Darjeeling to the effect that on 28.08.2025 at 22.15 hrs I received a reliable specific secret source input that one pearson would be come to Gate Bazar under PS – Pradhan Nagar, Dist. Darjeeling with huge quantity of illegal cough syrup on his back pack to delivery the same to his design customer.

Accordingly, the matter was diarized in PS General Diary vide Pradhan Nagar PS GDE No. 1747dated 28.08.2025 and I informed to you in writing. Subsequently, being directed by you at about 22.25 hrs myself along with SI Bandhan Roy, ASI Biplab Kr Das, ASI Prabal Sarkar and others force of Pradhan Nagar PS, SPC left for Gate Bazar, under PS Pradhan Nagar, Dist. Darjeeling without any search warrant or authorization for search which could not be possible to obtain from a competent authority for sudden development of such a sensitive information and also for not giving him opportunity for concealment of evidence or facility for his escape. This refers to Pradhan Nagar PS GDE No. 1748 dated 28.08.2025 and M.C.C. No. 1755/25 dated 28.08.2025. I also informed one Videographer namely Somnath Chatterjee, S/O Sushil Chatterjee of Arabinda Pally, Gokhel Road, Ward No 22, PS- Siliguri, Dist.-Darjeeling over telephone and requested him to come to Gate Bazar, under PS Pradhan Nagar, Dist. Darjeeling with his video camera for the purpose of video graphs if required. On the way, I briefed all the Police personnel properly sharing them the nature of information in hand. I also contact with RT Van officer ASI Anwar Abedin and share the information and directed him to come to Gate Bazar to accompany as well assist us.

At around 22.45 hrs we arrived at Gate Bazar, under PS- Pradhan Nagar, Dist. Darjeeling and after arriving at Gate Bazar, I requested two available independent persons namely (i) Kartik Sah (27 yrs) S/O Lt. Chandrika Sah of BRI Colony, Gate Bazar, PS- Pradhan Nagar, Dist. Darjeeling and (ii) Sujal Kr. Sah (22 yrs) S/O Goutam Sah of BRI Colony, Gate Bazar, PS- Pradhan Nagar, Dist. Darjeeling to remain present at the spot and act as independent witness if any search and seizure would be made upon which they agreed. I also issued notice to the above mentioned two independent witnesses. In the mean time RT mobile officers ASI Anwar Abedin along with force came at the spot to assist us. There after, I contacted my source who stated that the suspect carrying illegal cough syrup will come shortly by walking from Matigara side to deliver the same to his designated customers. At around 23.35 hrs as identified by the source, we noticed that one person carrying one black colour back pack on his back was coming towards Gate Bazar on foot from Matigara side. Accordingly, we cordoned the place from every possible corner and managed to detain him at Gate Bazar near Matri Bhandar under PS- Pradhan Nagar, Dist. Darjeeling with one black colour back pack on his back. Thereafter, we disclosed our identities as Police personnel (as I along with 4/5 police personnel were in civil dress for our convenience) and informed him regarding the information in hand. On interrogation, the detained person disclosed his identity as Md. Lalan (27 yrs) S/O Lt. Md. Mojim of Tulshi Nagar, PS Matigara, Dist Darjeeling and also disclosed that he is possessessing the cough syrup in his bag and came there to deliver the same to his designated customer. Then, I issued notice in writing to him whether he wanted to search his bag in presence of an Executive Magistrate or any Gazetted Officer as per norms of u/s 50 of NDPS Act, upon which he agreed to be searched in presence of any of the above noted officers.

Accordingly, I informed the matter to you over mobile phone and requested you to arrange an executive Magistrate or Gazetted Officer to supervise the entire process of search and if required seizure. At around 23.55 hrs the above mentioned videographer arrived at Gate Bazar with his camera. Accordingly, I served a notice to him to videograph the entire process of search and seizure if required. Furher at around 01.05 hrs on 29.08.25 you arrived at the spot at Gate Bazar under PS- Pradhan Nagar, Dist- Darjeeling to perform the duty of gazetted officer being the I/C of Pradhan Nagar PS and informed me that due to odd hours of night no Executive Magistrate was available and as a gazetted officer you are legally authorised to give order to search bag of the suspect.

Then, I served a notice to you to supervise the entire process of search and if required of seizure. Then on camera, I offered both the independent witnesses noted above and the detained person to search our Police Personnel as per provisions of law but they denied searching the Police personnel. Thereafter, in presence of you and independent witnesses noted above, I searched the black colour back pack of the above mentioned detained person namely Md. Lalan (27 yrs) S/O Lt. Md. Mojim of Tulshi Nagar, PS Matigara, Dist Darjeeling and recovered thirty six (36) bottles of Codeine Phosphate & Triprolidine HCL Syrup "ANNIREX" Cough syrup each bottle containing 100 ml. i,e total (36 X 100 ml= 3600 ml) having batch No NLF0115, Mfg date 06/25, Exp date 05/27, MRP Rs 175.00 (each bottle), from the back pack of the said detained person. On demand in presence of you and independent witnesses, the above mentioned detained person namely Md. Lalan (27 yrs) S/O Lt. Md. Mojim of Tulshi Nagar, PS Matigara, Dist Darjeeling failed to produce any valid document/papers for possessing or carrying such huge quantities of Codeine Phosphate based Cough Syrup. On further grilling, he confessed his guilt and stated that he procured the said quantities of "Codeine Phosphate based Cough Syrup" clandestinely from one of his suppliers for the purpose of selling the same in high rates to his selected customers for his wrongfull gain. He also stated that he was running such a business illegally for the last few months for his wrongful gain.

Accordingly, I seized the said articles viz :- one (01) black Colour bag pack styled as "adidas" Containing 36 (thirty six) bottles of Codeine Phosphate & Triprolidine HCL Syrup "ANNIREX" Cough syrup each bottle containing 100 ml. i,e total (36 X 100 ml= 3600 ml) having batch No NLF0115, Mfg date 06/25, Exp date 05/27, MRP Rs 175.00 (each bottle) Marked as Exhibit- "A" from the possession of accused person namely Md. Lalan (27 yrs) S/O Lt. Md. Mojim of Tulshi Nagar, PS Matigara, Dist Darjeeling under proper seizure list in presence of you and independent witnesses and obtained their signatures which is acknowledged by the accused person. Subsequently, I sealed and labelled the seized contraband articles in presence of you and independent witnesses and the above noted accused at the spot. The entire process of search, seizure and labelling were made under the coverage of a video graph executed by the videographer namely Somnath Chatterjee, S/O Sushil Chatterjee of Arabinda Pally, Gokhel Road, Ward No. 22, PS. Siliguri, Dist.- Darjeeling in between 01.15 hrs to 01.55 hrs on 29.08.25 as per norms of BNSS.

From the above noted facts and seizure of incriminating articles, it is quite evident that the offender namely Md. Lalan (27 yrs) S/O Lt. Md. Mojim of Tulshi Nagar, PS Matigara, Dist Darjeeling is involved in procuring and selling "Codeine Phosphate based Cough Syrup" illegally contravening the provisions of NDPS Act. Then, I arrested him after observing all formalities of arrest, informing him regarding the ground of his arrest.

Under the above fact and circumstances, I pray before you that a specific case under proper sections of law may kindly be registered against the arrested person namely Md. Lalan (27 yrs) S/O Lt. Md. Mojim of Tulshi Nagar, PS Matigara, Dist Darjeeling and kindly arranged its investigation.
