Sir/Madam,

With due respect I the above named complainant wants to state you that :-

- That the accused No: I is my Husband. Accused No: 2 is my Mother in law. Accused No: 3 is my Father in law. Accused No: 4 is my Sister in law Accused No: 5 is my Brother in law and Accused No: 6 is my Sister in law.
- That I got married with the accused No: 1 on 27th September 2018 according to Hindu Marriage Act under the Hindu culture and customs in Maa Bhabani Kali Mandir, Bidhan Road, Siliguri.
- 3. That after the marriage I lived in my matrimonial house which is situated at 2, Ichlabad, Durgatala, Nathpukur, P.O Sripalli, P.S Burdwan, Dt Bardwan, 713103.
- 4. That when I got pregnant the accused with their evil intention send me to my parents house and on 28th April 2019 I finally left my matrimonial

- house. Out from the wed lock a child namely Abir Pal who is now aged about 6 years and is studying presently at school
- That from 28<sup>th</sup> April 2019 the accused persons haven't took me in my matrimonial house even the accused did not come to look over my son.
- 6. That after few days from the marriage the accused started demanding money and flats in Kolkata. As I belong from a poor family therefore the accused used to torture me in high level. The accused did not give me proper food and clothing. They took away my phone so that I cannot talk to my parents. They keep me outside in varanda where I sleep. Several torture of physical abuse has been done to me.
- 7. That 28th April 2019 the accused stop paying me any sort of maintenance amount. Till date the accused haven't paid any sort of maintenance to me and my son. As now my son is growing up and monthly expenses is huge which I cannot bear it up accordingly I repeatedly call the accused to pay my and my son maintenance of Rs 20,000/- (Rs 10,000/- for me and Rs 10,000/- for my son) but all the accused remain silent.
- 8. That even my husband did not send his photograph, aadhar card so that I can make the form fill up in many school in Siliguri as during the form fill up both fathers and mother documents are being required. Now if my husband does not send me any maintenance money and his documents then my son have to stop his studies.
- 9. That every time I call the accused, the accused do not take over my phone and if by chance the accused took my phone, the accused started giving me very illicit slang languages to me and my parents. Even the accused denied to provide any sort of maintenance to me and my son so that my son's studies get hampered. According to then my is a curse to then and they do not accept my son.
- 10. That at any condition the accused do not wants to pay any amount to my son. I have talked with every accused but no one is talking any sort of responsibility of my son even my husband is declaring to keep my son in a home if I cannot maintain my son. I am in a very pathetic situation and now it becomes impossible for me to pay my sons school fees, tuition fees, bus fees, private fees, other activity fees etc. not a single amount has been paid

by my husband to me from 2019 to till date. Even at delivery time my parents have cleared all the medical bill that time also the accused haven't paid any single amount to them.

- 11. That recently I got information that my husband is going to marry another women by suppressing the fact of my and without taking any sort of divorce or paying me any sort of alimony to me and my son. My husband has got a very handsome income of Rs 1,50,000/- approx doing a private service in the post of technical lead Manager as by qualification, he is an electronics engineer. Beside my husband is also having a shop in the market area from which my husband earns an amount of Rs 1,00,000/- per month. Rent from his house which amount to Rs 50,000/-. In total the respondent is earning an amount of Rs 3,00,000/- per month or even higher.
- 12. That now I am in a very helpless situation. The accused do not send me any money for my and my son maintenance. The accused threats me over phone late at night. I am in a very distress position and I come before you seeking for justice. I request you to arrest the accused person immediately and to start a specific case against them together with an investigation upon which I will be helpful and thankful to you.
