Sir,

I, ASI Nilam Swarnakar of New Jalpaiguri PS, Siliguri Police Commissionerate, do hereby lodge written complaint, on producing one arrested accused person namely Narayan Roy (56/M) s/o Lt Prasanna Roy of Roy Para IOC road, PS New Jalpaiguri Dist.- Jalpaiguri under arrest along with following seized articles;

1. 13 (Thirteen) Nos sealed Bottles of Himalayan gold country spirit 60 up, each bottle 600 ml, Marked as Exhibit-A.

I am submitting a written complaint against the above noted accused person to the effect that on 28.08.2025 at 13.25 hrs. received source information that one person was selling Liquor illegally at Bhanumati road D.S Colony more under PS- New Jalpaiguri, Dist.- Jalpaiguri to its customers without any valid license. Accordingly I informed the matter to the duty officer of NJP PS and I.C. NJP PS and as per his instruction myself along with, C/1462 Sajan Tamang, VP- 13 Jamirul Islam, VP- 08 Laxman Roy all of NJP PS, SPC left for Bhanumati road D.S Colony more to verify the veracity of information vide NJP PS GDE No. 1481 Dated- 28.08.2025. On arrival at the spot at 13.40 hrs it was found that one person mentioned above was selling liquor illegally in his shop at Bhanumati road D.S Colony more to his designated customers to earn huge money for his livelihood. On seen the police party the customers as well as seller tried to flee away, but the seller was apprehended by police, on being asked he disclosed his name and address mentioned above and also confessed that he is selling Id Liquor illegally to his designated customers without any license. Thereafter in presence of witnesses I recovered the above noted articles from his possession and seized the same as per proper seizure List and labelled duly signed by him and also witnesses. On being asked the said person failed to produce any document or license for selling the liquor and confessed his guilt. As such I arrested the above noted accused person u/s 35 BNSS as It's a violation under Bengal Excise Act. The seizure & arrest was made on 28.08.25 in between 13-45 hrs. to 14-25 hrs. (seizure Total approx 7.8 Ltrs).

Therefore, I request you to start a specific case under the proper section of law against one arrested person namely Narayan Roy (56/M) s/o Lt Prasanna Roy of Roy Para IOC road, PS New Jalpaiguri Dist.- Jalpaiguri and arrange for its investigation.
