I ASI Manoj Majumder of New Jalpaiguri PS, SPC do hereby lodge a written complaint against the above noted accused persons and others 09/10 persons to the effect that on the night 28.08.25 at 21:55 hrs received secret source of information to the effect that some miscreants armed with deadly weapons assembled in a dark place at Kashmir colony Bus stand under NJP PS with a view to commit dacoit. Accordingly without waste any time I informed the matter to you and duty officer of PS. As per your kind direction at 22:05 hrs myself along with C/1462 Sajan Tamang, VP-13 Jamirul Islam VP 08 Laxman Roy left from PS vide NJP PS GDE No. 1515 dated. 28.08.25 for Kashmir colony Bus stand to verify the veracity of the information and to work upon it . We reached near the spot as confirmed by the source at about 22.30 hrs and stopped our vehicle at a considerable distance from that place and we started walking towards the mentioned place. When we reached nearby of Kashmir colony Bus stand and found a group of 13/14 persons assembled and gossiping in a dark place as stated by the source. We started approaching them slowly ambushing ourselves in the darkness. But unfortunately one of them see the police and try to flee away from the spot. Somehow, after a hot chase we could able to apprehend the above noted four (04) persons and the others 09/10 persons managed to flee away from the spot taking the advantage of darkness. On interrogation they disclosed their identity which was not verified and they also stated that they along with their other associates assembled there with a view to commit dacoit after making full preparation in the nearby place of Kashmir colony Bus stand under NJP PS. I try to manage the independent witnesses but due to late night I couldn't find any independent witness to be present at the time of search and seizure. Thereafter all the apprehended persons were searched and I found and recovered the above noted articles from their possession and seized the same under proper seizure list duly signed by them and the process of search and seizure has been recorded in audio-video means as per the provision of law. The seizure was made between 23:15 hrs to 23:27 hrs. Accordingly I arrested the above noted accused persons u/s 35 BNSS under proper memo of arrest and ground of arrest is duly communicated with them.

So I pray before yourself that a specific case may kindly be started against the accused persons namely 1) Ganesh Ghosh (20) s/o Mithu Ghosh of Ambikanagar PS NJP Dist Jalpaiguri 2) Koushik Das(25) s/o Bablu Das of of Ambikanagar PS NJP Dist Jalpaiguri 3) Raja Ghosh(28) s/o Satyen Ghosh of Ambikanagar PS NJP Dist Jalpaiguri 4) Sushil Sutradhar(18) s/o Sudeb Sutradhar of Santipara PS NJP Dist Jalpaiguri and other 09/10 persons under proper section of law and kindly arrange for its investigation.
