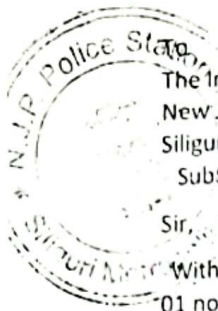

Sir,

With due respect, I am producing herewith one accused person namely Shajahan Ali (32/M) s/o Isamuddin of 01 no Joy Maa, PO- Bhodeyaguri, PS- Gossaigaon, Dist. Kokrajhar, ASSAM (Not Verified), under arrest along with seized cattle and seized vehicle ;

1. Ten (10) numbers of Buffalo and Eight (08) numbers of Buffalo Calves in Black colors and different sizes.
2. One Vehicle (Truck) having No. NL-01-AH-7664 which used to carry the seized Buffalo SL. No. 1.

I, SI Tanmay Kundu Of New Jalpaiguri PS under Siliguri Police Commissionerate do hereby lodged a written complaint against the above noted accused person ( driver) to the effect that on 28.08.2025 at 21.45 hrs. received a secret source information that some vehicles are being loaded with Buffalo illegally coming towards Jalpaiguri side from Phansidewa side without any valid documents/papers and if immediate action is taken, it can be apprehend . Accordingly I shared the information to I/C PS and on duty officer of PS. Thereafter as per his direction myself along with C/1462 Sajan Tamang , VP- 13 Jamirul Islam , VP- 08 Laxman Roy left for Fulbari to verify the veracity of information which diarized vide New Jalpaiguri PS GDE No. 1568 dt. 28.08.2025. At 22.05 hrs. We reached at Fulbari Toll Plaza under New Jalpaiguri PS and Just after some time on the basis of secret information we intercepted the one vehicle and apprehended the driver of the said vehicle having No. NL-01-AH-7664. On checking the vehicle we found Ten (10) numbers of Buffalo and Eight (08) numbers of Buffalo Calves in Black colors and different sizes were loaded on the vehicle. On being asked the apprehended driver disclosed his name and address mentioned above and admitted him as driver of the said vehicle and also stated he was carrying the Buffalo in his vehicle from Panjipara side towards Assam for selling the same illegally. On being asked, he failed to produce any License/ papers in support of carrying the said Buffalo in that vehicle and also failed to produce any papers/documents in respect of the said Buffalo. It is crystal clear and reason to believe that the above noted accused driver procured the said Buffalo by illegal means or by stolen means for dishonestly disposing of the same to earn huge money illegally. On further checking it was found that there was no arrangement made for food and water for the said Buffalo as per Govt. rules. Besides this there was no sufficient space for the Buffalo in that vehicle. The apprehended accused driver of the vehicle also failed to produce any papers/documents in support of the said vehicle. Accordingly I seized Ten (10) numbers of Buffalo and Eight (08) numbers of Buffalo Calves in Black colors and different sizes and (ii) One Vehicle (Truck) having No. BR-28GA-1786 which was used to carry the Buffalo , as per proper seizure list duly signed by the witnesses and arrested the apprehended person u/s 35 BNSS. The whole process of seizure and arrest have been made in between 22.30 hrs to 23.35 hrs.




