SUBJECT: FIR AGAINST PERSON DRIVING VEHICLE WB74BR1651 FOR FATALLY RUNNING PAMERCANNISSIONETALE
STREET DOG NEAR TRI-JUNCTION OF G. & C. ZONE LITTOR AVERAGE TO STREET AND THE STREET AND T

I, NEERAJ SEROHI resident of G01/04 Uttorayon Township, Matigara, 734010, a concerned citizen, hereby report an incident involving person driving vehicle WB74BR1651 responsible for reckless and negligent driving. A dog was brutally and fatally run over by this vehicle - WHITE, SMALL / HATCHBACK CAR REGISTRATION NUMBER ENDING 1651 on the G zone road near the tri-junction of C & G zone road at about 1130 am on 28th August 2025.

The vehicle description was shared by the horticulture labourers of CUWS (Chandmoni Uttorayon Welfare Society) who were working in the vicinity. I am reporting this incident since it happened near my house. Incidents of rash driving and over-speeding is widely prevalent on C & G zone road because there is very less traffic.

The vehicle was apprehended at about 515 pm by CUWS Security Team at the exit gate. Driver of the vehicle admitted to have committed this incident.

The vehicle is accused of committing the following offenses:

- 1. NEGLIGENT DRIVING: The driver of the vehicle was driving recklessly, putting the lives of pedestrians and street dogs, at risk. It is a common sight in Uttorayon Township to see speeding vehicles much above the stipulated 40 kmph.
- 2. ANIMAL CRUELTY: The driver's actions resulted in the death of a street dog, which is a form of animal cruelty.
- 3.VIOLATION OF MOTOR VEHICLE ACT: The driver failed to follow traffic rules and regulations, including speeding and failing to stop at the scene of the accident.

I request that the police take immediate action to:

- 1.INVESTIGATE THE INCIDENT: Conduct further investigation and take necessary action on the matter.
- 2. FILE CHARGES: File charges against the driver and owner of the vehicle for negligent driving, animal cruelty, and violation of the Motor Vehicle Act.
- 3. TAKE MEASURES TO PREVENT FUTURE INCIDENTS OF THIS NATURE: Work with local animal welfare organizations and CUWS to implement measures to prevent similar incidents in the future, such as installing speed bumps, posting warning signs, and conducting public awareness campaigns.

Please note that this not the first incident of such nature. In February 2025 and earlier also such incidents have been reported from the township.
