Sir,

With due respect and humble submission I SI Mrityunjoy Roy of Matigara P.S do hereby lodge this written complaint to the effect that today on 30/08/2025 I was deputed to perform Evening Patrol duty along with force, since 14:00 hrs vide Matigara P.S. C.C. No. 2622/25. Dated 30/08/2025 and GDE No. 1681, Dated - 30/08/2025. In course of said Patrol duty I received a source information that one Tractor is coming from Neemtala side loaded with River bed Materials towards Khaprail More which was procured clandestinely. On receipt of such information, I informed the matter to I/C Matigara PS over phone and as per his kind direction myself along with force rushed to Neemtala side and on way in front of NBU Gate No. 2, under P.S.- Matigara we found one Tractor bearing Regn. No. WB-74BN8810 with trolley loaded with river bed materials was speedily running towards Khaprail More. We managed to stop the vehicle but the driver/owner of said tractor jumped away from the tractor. It is crystal clear that the driver/owner of the Tractor bearing Regn. No. WB 74BN8810 procured the river bed materials from somewhere clandestinely and was proceeding to sale the same to their designated customer for their wrongful gain. I tried hard to trace out the absconded driver/owner of said tractor but in vain. Nobody came forward to claim the tractor to be his own. Finding no other alternatives, I seized the Tractor having Regn. No. WB 74BN8810, fitted with Trolley, loaded with River Bed Materials (Sand) with proper seizure list in presence of available witnesses. Brought the seized vehicle to Matigara P.S and kept at P.S Compound. Seizure was made on 30/08/2025 in between 16:35 hrs to 16:42 hrs. under proper videography.

I therefore pray before you that a specific case under proper section of Law may kindly be registered against driver/owner of the seized Tractor bearing Regn No. WB74BN8810 and arrange for it's investigation.
