

Sub: - F.I.R.

In producing herewith the accused person named Gopal Lama, aged 63 years, s/o- Late Jetha Lama, resident of Bhuttabari, Road No. 6, PS- Bagdogra, Dist- Darjeeling (Aadhaar No. 2923 3218 8971) under custody along with following seized articles under proper seizure list:

Two (02) ltrs 'Chullu' in one plastic bottle and marked as Exhibit-A.

2. Sixteen (16) bottles of "Himalayan Gold 60° UP India Made Liquor", each contains 600 ml @ Rs. 160/-, out of which 01 bottle is taken out as sample and marked as Exhibit-B. (Total 11.6 ltrs, total value Rs. 2560/-)

I, ASI Munna Ahmed of Bagdogra PS, S.P.C, Dist- Darjeeling, do hereby lodge this written complaint against the arrested accused person Gopal Lama, aged 63 years, s/o- Late Jetha Lama, resident of Bhuttabari, Road No. 6, PS- Bagdogra, Dist- Darjeeling to the effect that on 28.08.2025 at 12:45 hrs received reliable source information that a huge quantity of liquor is stored at the house cum shop of one suspect named Gopal Lama located at Bhuttabari, Road No. 6 under Bagdogra PS and the same has been selling illegally from his house cum shop for his wrongful gain. Accordingly, I informed the matter to O/C Bagdogra PS and diarised the matter in GD vide Bagdogra PS GDE No. 1294 dated 28.08.2025 and as per direction of O/C Bagdogra PS, I along with SI Binup Mahato, C/1509 Sourav Roy Sarkar, LCV/98 Shilpa Karmakar, CV/389 Janak Singh & CV/375 Jogesh Barman left for Bhuttabari, Road No. 6 under Bagdogra PS, SPC to work out the secret source information. Under these circumstances any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidences as well as for the escape of the offender. At around 13:00 hrs we reached at Bhuttabari, Road No. 6 and being indication & identification by source we held raid at the house cum shop of the suspect Gopal Lama and managed to apprehend the suspect with the help of accompanying Police personnel and interrogated him. On interrogation, he revealed his identity as Gopal Lama, aged 63 years, s/o- Late Jetha Lama, resident of Bhuttabari, Road No. 6, PS- Bagdogra, Dist- Darjeeling and introduced himself as the owner of that house cum shop. We disclosed our identity to him and the input we had. We contacted with the local people to be present as witness during the process of search, seizure, if any. Two independent witnesses named named Dhiraj Tamang, aged 23 years, s/o- Manshi Tamang, r/o- Bhuttabari, Road No. 7, PS- Bagdogra, Dist-Darjeeiing (Ph. No. 9064243827) and Bhanu Chawhan, aged 28 years, s/o- Late Ramlal Chawhan, r/o-Khudiram Pally, PS- Bagdogra, Dist- Darjeeling (Ph. No. 9064243827) were present there as independent witness. Then, we searched the house cum shop of the suspect Gopal Lama in presence of the independent witnesses as well as the Police personnel. On search, the above noted liquor was recovered from that house cum shop. On demand, he failed to produce any valid document/license for stocking, possessing & selling that liquor. He confessed that he had been stocking, possessing & selling liquor illegally from his house cum shop since long time for his wrongful gain. His involvement is well transpired in this case. Accordingly, I seized that liquor (as noted above) under proper seizure list and at last, I arrested the involved accused Gopal Lama (as noted above) after observing all legal formalities and communicating him the ground of arrest in writing as he has committed a cognizable offence in presence of Police for stocking, possessing & selling that liquor illegally and issued memo of arrest in this regard. The process of search, seizure & arrest was made in between 13:26 hrs and 13:45 hrs on 28.08.2025 through audio-video electronic means using mobile phone and then the same audio-video record is converted to a pen drive using computer system.

Therefore, I request that a specific case under proper section of law may kindly be started against the arrested accused person named Gopal Lama, aged 63 years, s/o- Late Jetha Lama, resident of Bhuttabari, Road No. 6, PS- Bagdogra, Dist- Darjeeling and arrange for its investigation.
