That I was married to Sarwan Paswan, (PH - 9239220990) son of Ramdas Paswan resident of Subash Pally, Bakrakote, Siliguri, P.O., P.S. Siliguri, District: Darjeeling, on 24 April 2024, as per Hindu rites and customs. At the time of marriage, my family gave Rs. 3,00,000 (Rupees Three Lakhs) in cash and other articles as dowry to my husband and his family according to their demand. After marriage, I started residing with my husband at his house situated at Subash Pally, Bakrakote, Siliguri, P.O & P.S. Siliguri, District: Darjeeling. However soon after marriage, my husband and his family members started harassing and torturing me both physically and mentally, demanding that I bring more money from my parents. That my husband is addicted to alcohol and under its influence he used to assault and abuse me on a regular basis. His sister and Aunt who stay with us also joined him in harassing and torturing me. That On January 21, 2025, I gave birth to my son at Pragati Nursing Home, Siliguri,

with no support from my husband and in-laws. And Even after the birth of my child, my husband and his family did not provide me any Financial support for daily household expenses. My mother had to send me money regularly to meet my and my Child's day to day needs, which caused great financial burden on my parential family. After knowing all these facts, my parents brought me to their home for my safety. At that time, my husband requested not to take any legal action against him and assured good behavior, so I returned back to my matrimonial home. But the harassment and torture continued as before.

On 15/08/2025, my husband along with his family members again pressurized me to demand Rs, 2,00,000 (Rupees Two Lakh) from my parents. When I refused, they severely beat me and even threatened to kill me. I Somehow, managed to inform my brothers, who rescued me and brought me back to my parental home. That finding no other option I am writing you this complaint against my husband and his family members.

Therefore, I with my folded hands request you to kindly register this FIR and take strict legal action against the people mentioned above.
