Sub : Complaint regarding violation of court injunction and continuation of illegal construction.

Ref : FIR no. 35/25 dated 14/01/2025.

Sir,

I, Sumit Garg, S/o Lt. Nagendra Kumar Agarwal, wish to inform you that despite an injunction order passed by the Hon'ble Court (Senior Division) on 10.01.2025, restraining Mr. Birendra Agarwal and Mr. Anil Kumar Agarwal both s/o Lt. Mangturam Agarwal from carrying out any construction activity at the suit property, the accused has willfully violated the order and resumed illegal construction on 25.08.2025.

The Hon'ble court order is reproduced as below :-

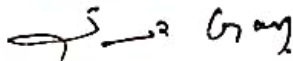
" that the ad interim injunction is allowed ex parte in favour of the plaintiffs. Both the plaintiffs and the defendants are directed hereby to maintain the status quo in regard to the peaceful possession, enjoyment and their respective interest in respect of the suit property and not to change the nature and character or raise any construction and/or development in respect of the suit schedule property and/or transfer, alienate or create any third party interest in respect of the suit property.

Recent activity by the accused seems to change the nature and character of the suit property and is irreversible which will lead to permanent damage to our interest in the said suit property.

An FIR bearing number 35/25 dated 14/01/2025 was previously filed at your police station regarding the same issue. However, despite this, the accused is continuing with illegal activity in defiance of the law.

This constitutes a clear violation of Section 223 of BNS and is contempt of court. I request you to take urgent legal action against the accused, stop the construction activity immediately, and ensure compliance with the court's order.
