In the month of February, 2024, I have been requested him for returning my vehicle to me and he told me that after 2 -3 month I shall return your vehicle positively. After passing 4 (four) month he did not return my vehicle and thereafter I have been went at Siliguri for returning my vehicle. At that time Abhisekh Singh told me that he needs more time for returning the same as because he has provided the vehicle to one company.
