Respected Sir,

1. **That I, Maya Mehta, daughter of Shri Arun Mandal,** am the complainant in the present case, presently residing at ISKON Mandir Road, near Pepsi Godown, Paradise Building, P.S. Bhaktinagar, District Jalpaiguri, Pin - 734001, and having my permanent address at Section-AS, Sadarpur Colony,

near Indian Public School, District Bareilly, P.S. Sector-45, Noida, Uttar Pradesh, Pin - 201301.

2. **That I was lawfully married to the accused No. 1, namely, Mintu Sarkar @ Akash Sarkar, son of Bablu Sarkar, on 12th March 2023, as per Special Marriage Act, and the said marriage is evidenced by Marriage Certificate No. WB32801002060202892-2023-22266, issued by the Registrar General of Marriages, Government of West Bengal. The said certificate bears the photograph, names, and signatures of the parties and witnesses and is annexed herewith.**
3. **That immediately after my marriage, I was subjected to severe mental and physical cruelty, physical assaults, filthy abuses, and constant humiliation at the matrimonial home situated at Pipeline Road, Madhya Shantinagar, Dabgram, District Jalpaiguri, Pin - 734004. I was compelled to part with my hard-earned income from my employment at Alishan Bagicha Bar, Sevoke Road, Siliguri, under coercion and threat.**
4. **That unable to bear the continuous cruelty, I left my matrimonial home about six months ago, yet instead of mending his ways, accused No. 1 escalated his vendetta by embarking upon a systematic campaign of cyber harassment, blackmail, defamation, and intimidation against me.**
5. **That accused No. 1 created fake social media accounts and deliberately uploaded, circulated, and transmitted my private and intimate photographs and videos without my consent, thereby outraging my modesty, assassinating my character, and reducing my dignity in society. The specific links evidencing such heinous cyber crimes are:**

6. **That apart from publishing obscene content, the accused has continuously abused me in vulgar language and threatened me with dire consequences including death threats. On WhatsApp and other platforms,**

he has used obscene expressions such as "Randi" and "MC" with the sole intent to terrorise me. Screenshots are annexed to this complaint.

7. **That in these nefarious and criminal activities, one Mithun Sarkar (son of Ranjan Sarkar, mobile no. 8981719575, resident of Haiderpara, Araf Tower, in front of Apollo Pharmacy, 3rd Floor, Siliguri), has been actively colluding with accused No. 1. He has participated in the creation of fake accounts, editing of my private images, and spreading the obscene content with malicious intention.**
8. **That the deliberate and pre-planned acts of both accused persons constitute not only marital cruelty and criminal intimidation but also the most heinous forms of cyber-pornography and digital defamation. Their acts are designed to outrage my modesty, assassinate my reputation, cause me irreparable mental trauma, and drive me into a state of fear and social isolation.**
9. **That the accused persons are liable for serious cognizable offences punishable under Sections 66C, 66D, 66E, 67, and 67A of the Information Technology Act, 2000, and also under the provisions of the Bharatiya Nyaya Sanhita, 2023, and allied provisions relating to cruelty, criminal intimidation, defamation, conspiracy, and publication of obscene material.**
10. **That the offences are grave, continuous, and of far-reaching consequence, and unless your office intervenes immediately, more obscene material may be disseminated and my life, dignity, and safety will be placed in further danger.**
11. **That I am enclosing the following documents and digital records along with this complaint:**
 - Certified copy of Marriage Certificate dated 12.03.2023.
 - Aadhaar of accused No. 1.
 - Screenshots of abusive WhatsApp chats.
 - Screenshots of Instagram and Facebook accounts and posts.
 - Screenshots of DMs evidencing threats and blackmail.
 - Hyperlinks of fake accounts used for harassment.

Therefore, I most humbly but firmly demand that your good office:

1. **Register an FIR** against accused No. 1 *Mintu Sarkar @ Akash Sarkar* and accused No. 2 *Mithun Sarkar* under the aforesaid provisions of IT Act and BNS.
2. **Trace the IP addresses, device IDs, and digital footprints** of the fake accounts and secure digital evidence without delay.
3. **Send immediate takedown notices** to Instagram and Facebook to block and delete all obscene and defamatory content.
4. **Seize and forensically examine the mobile phones, laptops, and devices** of the accused.
5. **Provide me adequate police protection** in view of the continuous threats to my life and dignity.
6. Initiate strict legal proceedings to ensure the accused are prosecuted, punished, and prevented from committing further crimes.
