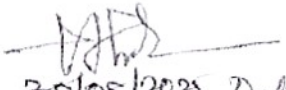

This is to inform you that I Anjan Layek, Son of Himangshu Layek, resident of 12th Battalion, Dabgram, Dist - Jalpaiguri. On 26/8/25 I received a friend request at facebook named "Aarti Sharmi". After accepted that request she started talk to me. Then she want my whatsapp number and start video calling me. As I received that video call she ^{started} show me her naked body and told me to open my belongings. After a few minutes she made a video and sent me through facebook messenger and asked me for money and threatened me. On dated 27/8/25 I received a phone call from cyber crime department (M-06375939345) a employee of named Avinandan Rathore. He informed me that someone uploaded a video of mine at many social media and if I want to delete that video I had to pay for that. Then he sent me a phone number of a YouTuber (M-08955851894) named Sanjay Singh. When I contact that person he told me to pay Rs 9500/- to delete that video. I had paid that

P.T.O

amount through U.P.I. Then he told me that I had paid that amount wrongly. I had to paid Rs 9000/- and Rs 500/-. I was so much confused that time and sent him Rs 9000/- and 500/- rupees. Then he asked me for Rs 21000/- and Rs 500/- as there are so many social media and they posted that video every where. So I paid Rs 21000/- as Rs 500/- to him through U.P.I. After they demanding 20,000/- and 31000/- for withdrawal the F.I.R. which the register against me. Then he demanding more money and I had paid total Rs 1,77,500/- through U.P.I. Now they demanding more money and I realise they cheated me.

Therefore I request you to accept my diary and take necessary actions against them and refund my money.
