I, **JOYDEB BISWAS**, son of Late Kartick Biswas, permanent resident of Vill. Kawakhali, P.O. Sushrutanagar, P.S. Matigara, Dist. Darjeeling, would like to inform you that as follows:-

1. That I am a law abiding citizen of India. I have been residing along with my parents since my birth at my above mentioned residence peacefully and honestly.
2. That today i.e. 31.08.2025 at about 6.00 P.M. when I came out from my above mentioned residential address along with my friend Uday Kundu, Son of Utpal Kundu, with my motor cycle towards the A.H. 02 suddenly at Kawakhali, Bidhan Pally road one person namely **PRADIP DEBNATH**, son of Jitendra Debnath, permanent resident of Vill. Kawakhari, near Aastha Nursing home, P.O. Sushrutanagar, P.S. Matigara, Dist. Darjeeling, who was also plying motor cycle while talking to his mobile phone driving recklessly at a very high speed suddenly, dashed me from front with his motor cycle and as a result I lost my control and I and my friend (pillion) namely Uday Kundu fell in the ground along with my motor cycle. Suddenly the nearby people picked us up and my motor cycle. I received several injuries on my head and my body but said PRADIP DEBNATH without saying anything hit me below my left eye with a fist by holding his motor cycle key and as a result the key pierced into my face and I immediately fell on the ground again and due to unbearable pain and blood lost I lost my consciousness. When I regained my consciousness I found myself admitted to N.B.M.C. & Hospital. Currently I am under treatment.

I therefore request you to kindly take necessary legal steps against **PRADIP DEBNATH**. I shall be highly obliged to you forever.
