I, Sri Pradip Debnath, Son of Jitendra Debnath resident of Kawakkhari, PO Susrth Nagar, PS Matigara, Dist Darjeeling, beg to lodge a complaint in following effects that on today i.e. on 31th August 2025 at around 5.30 PM when I move towards Kawakhali region from residence, 1)Gopal Biswas and 2)Joydev Biswas S/o Late Kartik Biswas,
