Respected Sir,

I, Sri Pradip Debnath, Son of Jitendra Debnath resident of Kawakkhari, PO Susrth Nagar, PS Matigara, Dist Darjeeling, beg to lodge a complaint in following effects that on today i.e. on 31th August 2025 at around 5.30 PM when I move towards Kawakkhari region from residence, 1)Gopal Biswas and 2)Joydev Biswas S/o Late Kartik Biswas, 3)Kartik Dhali S/O Juran Dhali, 4)Uday Kundu S/O Utpal Kundu, 5)Manik Sarkar S/O Rakhal Sarkar, 6)Jayanta Biswas S/O Sukhlal Biswas and associates blocked my ~~husband's~~ road and demanded a sum of Rs. 50,000/- as gunda tax for which I denied and thereafter they started to beat me mmercilessly with deadly weapons viz. Wooden sticks, iron rod etc. under a manner to kill me. When I shouted for help, due to local people intervention I managed to safe myself and on local people arrival, they left the place with threatening to kill me. During the incident, they snatched my gold chain and also snatched 15000/- cash from my possession. Out of the said attack I got serious bodily injuries and immediately treated at North Bengal Medical College and Hospital. Right now I'm living under life theeat.

So it is therefore requested to take appropriate legal action/s against the above 1)Gopal Biswas and 2)Joydev Biswas S/o Late Kartik Biswas, 3)Kartik Dhali S/O Juran Dhali, 4)Uday Kundu S/O Utpal Kundu, 5)Manik Sarkar S/O Rakhal Sarkar, 6)Jayanta Biswas S/O Sukhlal Biswas and associates for the proper administration of Justice.
