I, Sri Manobendra Bepari@ Manav, S/o. Sri Nirmal Byapari, R/o. Vastu Bihar, Ganga Apartment, P.O. & P.S. Matigara, Dist. Darjeeling, would like to inform you that I contact with a woman / Lady namely Smt. Puja Adhikary, D/o. Sri Bankim Adhikary, R/o. Baneshwar more, North Ektiasai, P.S. Bhakti Nagar, Dist. Jalpaiguri through SAMAJ SATHI APP (Matrimonial Platform) and after that me and the aforesaid lady contact with each other as a regular basis on over telephone and on 17/08/2025 the aforesaid lady came to my above mentioned residence and told me that she wants to marry me and I also accepted her proposal and during that time both were major and for that reason me and the aforesaid lady went to Jalpaimore Kali Mandir, Siliguri and we got married with each other as per Hindu Rites and Customs after that we started to live together as a husband and wife at my avove mentioned residence and after few days of our marriage i.e. on 22/08/2025 at about 01:00 P.M. the family members of my wife at atleast 15 persons came at my residence and organized one Ashirbad Ceremony and during that time the family members of my wife accepted us and thereafter we started happy conjugal life.

It is pertinent to mention here that on 27/08/2025 at about 05:30 P.M. the family members of my wife namely 1. Sri Prasanjit Adhikary, 2. Sri Sanju Adhikary, both of them are son of Sri Bankim Adhikary, 3. Sri Bankim Adhikary, S/o. Not Known, 4. Aloka Adhikary, W/o. Sri Bankim Adhikary, all of them are R/o. Baneshwar more, North Ektiasai, P.S. Bhakti Nagar, Dist. Jalpaiguri and four Unknown Male person (I can identify if I see them) suddenly entered at my residence and without any reasons the above named person namely Sri Prasanjit Adhikary with an intention to kill me he attacked on me and with the help of helmet he assaulted on my head and due to said reason bleeding started from my head and I fell down on the floor and after that the above named person namely Sri Sanju Adhikary taking advantage of the same he with the

Therefore I request you be pleased to take necessary legal action against above noted persons as early as possible.
