The complainant above named begs to state as follows :-

- 1. That the Complainant is a law abiding and peace loving citizen of this country.
- 2. That since more than 40 (forty) years back, a partnership firm had been constituted under the name and style 'M/s Biswanath Champalal' amongst the predecessors of the complainant and from time to time the said partnership firm had been reconstructed, sometimes due to the death of the partners and sometimes for the retirement of the partners and introduction of the new partner or partners in accordance with the due process of law.
- Solemnly Affirmed & Office of the complainant namely Brij Mohan Mitruka (since before the on Mitruka and the complainant framework and Sri Prem Prakash adfind the said reconstruction was the last indenture and since the date of the said reconstruction said partnership firm M/s Biswanath Champalal had/have started to conduct the lawful business with the profit sharing ratio of 25% each with good reputation in accordance with the terms and conditions as laid down in the original deed of partnership of reconstruction.
 - 4. That the accused person no. 1 being the elder son of the family and being entrusted by the other partners i.e., the father of the

complainant, Brij Mohan Mitruka, younger brother namely Prem Prakash Mitruka and the complainant for looking after the day to day business and other day to day affairs of the said partnership firm, the accused person no. 1 had/has accepted the said entrustment and operating the business of the said partnership

- 5. That father of the complainant Brij Mohan Mitruka (since deceased) as one of the partner of the said partnership firm had died on 25.04.2023 and after his demise, there was no further reconstruction of the said partnership firm and the complainant had/have always relied upon the accused person no. 1 and he has always assured the complainant that the said partnership is making the profit well.
- 6. That very recent the complainant came to know that the accused person no. 1 has removed the complainant from the said partnership firm showing the said HUF as retired and the complainant also came to know that for the purpose of the said purported retirement, the signature of the complainant as the Karta of the said HUF has been forged by the accused person no. 1 in connivance with his wife i.e., the accused person no. 2 and his son i.e, the accused person no. 3 respectively and after the said purported retirement/removal, the accused person no. 1 has reconstructed the new partnership deed by introducing the accused person no. 2 and 3 as the new partners therein.
- 7. That the accused person no. 1 has relied the said purported partnership deed of reconstruction for the purpose of submitting nniy Affirmed & Declarsubmission of the false and fabricated statements before the Affirmed & Description of the talse and fabricated statements before the neity of identification of deed has been purportedly manufactured and present the lawful interest of the lawful interest. the lawful interest of the complainant.

That the said illegal and fraudulent deliberate act and activities from the end of the accused persons, the complainant being the Karta of the HUF and a family member did not want to proceed against the accused persons in the court of law considering the family reputation, goodwill and other legal consequences and hazard and for avoiding the above-mentioned complication the complainant had served a legal notice on 17.03.2025 to the

complainant, Brij Mohan Mitruka, younger brother namely Prem Prakash Mitruka and the complainant for looking after the day to day business and other day to day affairs of the said partnership firm, the accused person no. 1 had/has accepted the said entrustment and operating the business of the said partnership firm.

That very recent the complainant came to know that the accused person no. 1 has removed the complainant from the said partnership firm showing the said HUF as retired and the complainant also came to know that for the purpose of the said purported retirement, the signature of the complainant as the Karta of the said HUF has been forged by the accused person no. 1 in connivance with his wife i.e., the accused person no. 2 and his son i.e, the accused person no. 3 respectively and after the said purported retirement/removal, the accused person no. 1 has reconstructed the new partnership deed by introducing the accused person no. 2 and 3 as the new partners therein.
- 7. That the accused person no. 1 has relied the said purported partnership deed of reconstruction for the purpose of submitting the income tax return and for obtaining the audit report and submission of the false and fabricated statements before the concerned department knowingfully well that the partnership deed has been purportedly manufactured and prepared to deceive the lawful interest of the complainant.
- 8. That the said illegal and fraudulent deliberate act and activities from the end of the accused persons, the complainant being the Karta of the HUF and a family member did not want to proceed against the accused persons in the court of law considering the family reputation, goodwill and other legal consequences and hazard and for avoiding the above-mentioned complication the complainant had served a legal notice on 17.03.2025 to the

accused persons and another brother Sri Prem Prakash Mitruka and requested therein to remove their illegal act but inspite of receiving the said notice, the accused persons did not respond the same.

- 9. That on 18.04.2025, the accused person no. 1 and 3 have forcibly entered into the house of the complainant and threatened him by giving the ultimatum to withdraw the said legal notice and also threatened him that if the complainant take any legal step, the accused persons will give a remarkable lesson and on protest as made by the complainant and his wife, Smt Shalini Mitruka, the accused person no. 1 and 3 assaulted the complainant by fist and blows and during the said altercation, they also pushed his said wife and abused her in filthy languages which cannot be uttered in a civilized society and they have damaged the valuable wrist watch of the complainant alongwith other household articles.
- 10. That the complainant had tried to lodge the written complaint with the local police station but the same has been refused and hence the complainant has lodged a written complaint with the Commissioner of Police, Siliguri Police Commissionerate on 19.04.2025 but till this day no action has been taken by the concerned police authority.
- 11. That the present complaint is bona-fide one and for the ends of justice.

Under the above circumstances it is therefore prayed that your Honour may graciously be pleased to send this complaint to the Inspector In-Charge, Siliguri Police Station with a direction to investigate the matter after treating this complaint as FIR as per the provision of section 175 (3) of B.N.S.S, 2023 for the ends of justice.

And for this act of kindness your petitioner as in duty bound shall ever pray.
