With due respect, I Smt. Lopa Roy w/o Dipu Roy, resident of North Ektiyasal, I.O.C Pipeline, W/No. 40 (S.M.C), P.SBhaktinagar Nagar, Dist. – Jalpaiguri, would like to inform you that I was married to one Sri. Dipu Roy, Son of Mitinglal Roy resident of North Ektiyasal, I.O.C Pipeline, W/No. 40 (S.M.C), P.S Bhaktinagar Nagar, Dist. – Jalpaiguri, in the month of February, 2014, since the marriage my husband, i.e., Dipu Roy and his family members including his brother, mother and father was torturing me on bringing more dowry and cash from my parental home, on denial they have sunk to this level that often I was beaten by them and thrown me out of the matrimonial house but still I tried to adjust with my above mentioned husband and in-laws with a hope that by the lapse of time their conduct, act, behavior would be change but all such in vein.

After 2 years out of the said wedlock one female child was born namely Manvee Roy on 27/10/2016, at that time I thought that may be the behavior of my Husband would have changed by having a child but his torture increased day by day toward me. He often drove me out of the house at mid night then having no other option I use to take shelter at my friend's house. After many requests, my husband letting me enter the house. This kind of incidents happened many times. Sometimes my husband used to harass me in front of my friend's husband by saying filthy and indecent remarks, but still I always adjust with myabovementioned husband with a hope that someday this kind of ill treatment of my abovementioned husband towards me would be stopped but on provocation by above mentioned the in-laws my husband got furious toward me without any reasons.

On 23/11/2022 I gave birth to another male child namely Rutyik Roy out of the said wedlock, but the situation remains same. Many restless, dreadful and

sleepless night I have spent throughout the years as my husband used to come home in drunken condition and without any reason, I have been beaten up by him. In the month of march of 2024, we have come to a written agreement about I shall not bear anymore physical and mental abuse by him and his family members but he breached that agreement.

On 24/08/2025 the situation escalated to such an extent that my husband brutally assaulted me physically, resulting which I got admitted in the Hospital and after got intensive medical treatment I have been discharged from the hospital. My husband drove me out of the house therefore recently I residing at my friend's house. My husband retain all my necessary documents, regular used apparels, and my Royal Enfield bike, which is purchased by me alone due to physical weakness I could not struggle to get that above mentioned necessary things from him.

So Sir, I shall be highly obliged if you kindly take necessary legal steps in this regards against my above named Husband and in-laws and do the needful accordingly and kindly assist me in retrieving my necessary documents and regular used clothing. Due to physical weakness following my discharge from the hospital, I was unable to file the F.I.R. promptly, which resulted in a delay.
