SUBJ: Attempt to murder To Subhasit Roy falling for  
under Section 307 IPC.

Respected Sir,

I Subhasit Roy S/o. Rudra Kumar Roy Hasmata  
and wife ~~ex~~ Ke Red Samir Roy Samir Parash  
Nagar Ward no 44 Siliguri Jalpaiguri. wish to lodge  
a formal complaint against a violent and criminal  
assault committed on me with an intent murder  
Details of incident :-

on 31st Aug 2025 at around 11:30 PM while within  
the premises of my residence area located at  
Samir Roy Samir Parash Nagar Sevoke Road Siliguri  
Ward no 44 I was attacked by a group of boys  
known to me by appearance and individuals involved  
are :- BISHU SARKAR / SAHMAZ HUSSAIN / RINTU / RINKU  
SUBHANIKAR / RAHUL MODAK / and others

They were armed with metal Rods/pipes and  
guns. without any provocation, they started  
assaulting me with the clear intent to kill me  
I was hit multiple times including a severe blow  
my head which caused heavy bleeding. The force  
and nature of the attack clearly show  
their intent to cause fatal injuries, falling under the



Scope of section 307 of the Indian Penal Code  
ATTEMPT TO MURDER.

AFTER the incident I was immediately rushed to  
Civil hospital Siliguri, where I was received  
Emergency medical treatment. While the criminal  
attacked in front of police by the BSY SARKAR  
was known as 'Bangledehi' and I was protected  
by Bhaktinagar police.

I have attached a copy of the medical report  
issued by the hospital, which details the seriousness of  
my injuries.

This attack was not a simple assault but a  
deliberate and coordinated attempt to end my  
life and therefore must be treated as a heinous  
crime. I am in a state of shock and trauma  
and I fear for my safety.  
Requested for Action.

I kindly request you to register an FIR  
under appropriate sections, including but not limited  
to:- Section 307 IPC - ATTEMPT TO MURDER  
SECTION 323 IPC - VOLUNTARILY CAUSING HURT  
SECTION 324/326 IPC - Causing hurt with dangerous  
weapons like kutta, gun, hockey stick, normal stick  
and knife with others.  
Section 34 IPC - ACT done by several persons in  
furtherance of common intention.

I also request you to immediately arrest  
the accused persons and initiate strong legal action  
against them. Given the severity of the crime

I urge the police to oppose any bail application they may file as they are a threat to my life and public safety.

I am ready to cooperate fully with the investigation and provide any further information or evidence as needed.
