I, Ankush Yadav S/O Late Rambalak Yadav resident of New Pokaijote, Ward No. 46, under Siliguri Municipal Corporation is a worker in the Regulated Market. ^{yesterday} ~~Today~~ at around 10.30 pm, near stall no.TB 1 while returning from the cultural program of the Ganpati Puja in Regulated Market, Shib Narayan Yadav S/O Late Shri Yadav alias mandal Santosh Yadav S/O Amarjeet Yadav, Ramesh Yadav S/o Sri Shivji Yadav, Chandan Yadav S/o Gango Yadav, Abhishek Yadav S/O Ramjapo yadav, Shib kumar yadav S/O Umashankar Yadav, Raaz yadav alias Mangal S/o Shyam yadav, Binod yadav S/O Leelo yadav, Rupesh Yadav S/O Leelo Yadav surrounded me and beaten me up to kill me with knife, arms, hockey sticks and rods which they were carrying in hands. I have been beaten brutally on my lower back, stomach and elbows. I any how escaped and saved my life but I fear they will again attempt to kill me and my family.

Therefore Sir, I request you to kindly investigate and take necessary action against the culprits and goons. I am feeling unsafe, threatened and fearing my life is at risk as these goons might attack me and my family and kill us at any point of time. Looking forward for your kind intervention and cooperation. Will be highly obliged and grateful to you.
