

Sir, In producing herewith one (01) accused person namely Kamal Kamti (26 yrs) S/O Bhagirath Kamti of Binay Nagar, Chaitanyapur, Balasan, PS- Matigara, Dist. Darjeeling under arrest along with the following seizure articles viz: one (01) ash Colour bag pack having four comperments styled as "Lunar's" Containing 40 (forty) bottles of Triprolidine Hydrochloride Codeine Phosphate Syrup "BLUREX-T" Cough syrup each bottle contains 100 ml. i,e total (40 X 100 ml= 4000 ml) having batch No TBHX1008, Mfg date 03/2025, Exp date 02/2027, MRP Rs 180.00 (each bottle) Marked as Exhibit-"A". I, SI Rajiv Subba S/O Basant Subba of Pradhan Nagar PS, Siliguri Police Commissionerate do hereby lodged this written complaint against the above noted one (01) arrested accused person namely Kamal Kamti (26 yrs) S/O Bhagirath Kamti of Binay Nagar, Chaitanyapur, Balasan, PS- Matigara, Dist. Darjeeling to the effect that on 31.08.2025 at 18.20 hrs I received a reliable specific secret source input that one pearson would be come to Siliguri Junction area under PS – Pradhan Nagar, Dist. Darjeeling with huge quantity of illegal cough syrup on his back pack to delivery the same to his design customer.

Accordingly, the matter was diarized in PS General Diary vide Pradhan Nagar PS GDE No. 1916 dated 31.08.2025 and I informed to you in writing. Subsequently, being directed by you at about 18.35 hrs myself along with SI Goutam Mallik, SI Bandhan Roy, ASI Prabal Sarkar and others force of Pradhan Nagar PS, SPC left for Siliguri Junction under PS Pradhan Nagar, Dist. Darjeeling without any search warrant or authorization for search which could not be possible to obtain from a competent authority for sudden development of such a sensitive information and also for not giving him opportunity for concealment of evidence or facility for his escape. This refers to Pradhan Nagar PS GDE No. 1917 dated 31.08.2025 and M.C.C. No. 1781/25 dated 31.08.2025. I also informed one Videographer namely Somnath Chatterjee, S/O Sushil Chatterjee of Arabinda Pally, Gokhel Road, Ward No 22, PS- Siliguri, Dist- Darjeeling over telephone and requested him to come to Siliguri Junction under PS Pradhan Nagar, Dist. Darjeeling with his video camera for the purpose of video graphs if required. On the way, I briefed all the Police personnel properly sharing them the nature of information in hand. I also contact with RT Van officer ASI Sajal Das and ASI Anwar Abedin and share the information with them and directed them to come to Siliguri Junction to accompany as well assist us.

At around 18.50 hrs we arrived at Siliguri Junction under PS- Pradhan Nagar, Dist. Darjeeling and contacted with my source while he informed that the person who possessing cough syrup will come to Public Bust Entry Gate, Siliguri Junction to deliver the same to his customers shortly. Then, I contacted with two available independent persons namely (i) Suraj Paswan (30 yrs) S/O Gopal Paswan of Rajendra Nagar, Coolipara, Ward No-01, PS- Pradhan Nagar, Dist. Darjeeling and Krishna Dusadh S/O Late Narayan Dusadh of Rajendra Nagar, Coolipara, Ward No-01, PS- Pradhan Nagar, Dist. Darjeeling and shared the information with them and requested them to remain present at the spot and act as independent witness if any search and seizure would be made upon which they agreed and gave their concent verbally. I also issued notice to the above mentioned two independent witnesses. In the mean time RT mobile officers ASI Anwar Abedin and ASI Sajal Das along with force came at the spot to assist us. There after, I again contacted my source who stated that the suspect carrying illegal cough syrup will come shortly by walking from Gate Bazar side to deliver the same to his designated customers at public bus entry gate, Siliguri Junction. At around 20.15 hrs as being identified by the source, we noticed that one person carrying one back pack on his back was coming towards Siliguri Junction Public Bus Entry gate on foot from Gate Bazar side. Accordingly, we cordoned the place from every possible corner and managed to detain him at Public Bus entry Gate, Siliguri Junction under PS- Pradhan Nagar, Dist. Darjeeling with one ash colour back pack on his back. Thereafter, we disclosed our identities as Police personnel (as I along with 4/5 police personnel were in civil dress for our convenience) and informed him regarding the information in hand. On interrogation, the detained person disclosed his identity as Kamal Kamti (26 yrs) S/O Bhagirath Kamti of Binay Nagar, Chaitanyapur, Balasan, PS-Matigara, Dist. Darjeeling and also disclosed that he is possessessing the cough syrup in his bag and came there to deliver the same to his designated customer. Then, I issued notice in writing to him whether he wanted to search his bag in presence of an Executive Magistrate or any Gazetted Officer as per norms of u/s 50 of NDPS Act, upon which he agreed to be searched in presence of any of the above noted officers.

Accordingly, I informed the matter to you over mobile phone and requested you to arrange an executive Magistrate or Gazetted Officer to supervise the entire process of search and if required seizure. At around 21.25 hrs the above namced videographer arrived at Siliguri Junction with his camera. Accordingly, I served a notice to him for videograph the entire process of search and seizure if required. Furher at around 21.50 hrs you arrived at the spot (public Bus entry Gate, Siliguri Juncton under PS-Pradhan Nagar, Dist-Darjeeling) to perform the duty of gazetted officer being the I/C of Pradhan Nagar PS and informed me that due to holiday of Sunday no Executive Magistrate was available and as a gazetted officer you are legally authorised to give order to search bag of the suspect.

Then, I served a notice to you to supervise the entire process of search and if required of seizure. Thereafter on camera, I offered both the independent witnesses noted above and the detained person to search our Police Personnel as per provisions of law but they denied searching the Police personnel. Then, in presence of you and independent witnesses noted above, I searched the ash colour back pack of the above mentioned detained person namely Kamal Kamti (26 yrs) S/O Bhagirath Kamti of Binay Nagar, Chaitanyapur, Balasan, PS- Matigara, Dist. Darjeeling and recovered 40 (forty) bottles of Triprolidine Hydrochloride Codeine Phosphate Syrup "BLUREX-T" Cough syrup each bottle containing 100 ml. i,e total (40 X 100 ml= 4000 ml) having batch No TBHX1008, Mfg date 03/2025, Exp date 02/2027, MRP Rs 180.00 (each bottle) from the back pack of the said detained person. On demand in presence of you and independent witnesses, the above named detained person failed to produce any valid document/papers for possessing or carrying such huge quantities of Codeine Phosphate based Cough Syrup. On further grilling, he confessed his guilt and stated that he procured the said quantities of "Codeine Phosphate based Cough Syrup" clandestinely from one of his suppliers for the purpose of selling the same in high rates to his selected customers for his wrongful gain. He also stated that he was running such a business illegally for the last few months for his wrongful gain.

Accordingly, I seized the said articles viz:- one (01) ash Colour bag pack having four comperments styled as "Lunar's" Containing 40 (forty) bottles of Triprolidine Hydrochloride Codeine Phosphate Syrup "BLUREX-T" Cough syrup each bottle containing 100 ml. i,e total (40 X 100 ml= 4000 ml) having batch No TBHX1008, Mfg date 03/2025, Exp date 02/2027, MRP Rs 180.00 (each bottle) Marked as Exhibit-"A" from the possession of accused person namely Kamal Kamti (26 yrs) S/O Bhagirath Kamti of Binay Nagar, Chaitanyapur, Balasan, PS- Matigara, Dist. Darjeeling under proper seizure list in presence of you and independent witnesses and obtained their signatures which is acknowledged by the accused person. Subsequently, I sealed and labelled the seized contraband articles in presence of you and independent witnesses and the above noted accused at the spot. The entire process of search, seizure and labelling were made under the coverage of a video graph executed by the videographer namely Somnath Chatterjee, S/O Sushil Chatterjee of Arabinda Pally, Gokhel Road, Ward No. 22, PS. Siliguri, Dist.- Darjeeling in between 22.05 hrs to 22.45 hrs as per norms of BNSS.

From the above noted facts and seizure of incriminating articles, it is quite evident that the offender namely Kamal Kamti (26 yrs) S/O Bhagirath Kamti of Binay Nagar, Chaitanyapur, Balasan, PS-Matigara, Dist. Darjeeling is involved in procuring and selling "Codeine Phosphate based Cough Syrup" illegally contravening the provisions of NDPS Act. Then, I arrested him after observing all formalities of arrest, informing him regarding the ground of his arrest.

Under the above fact and circumstances, I pray before you that a specific case under proper sections of law may kindly be registered against the arrested person namely Kamal Kamti (26 yrs) S/O Bhagirath Kamti of Binay Nagar, Chaitanyapur, Balasan, PS- Matigara, Dist. Darjeeling and kindly arranged its investigation.
