I, **Raj Kiran Routh**, S/O. Raju Routh, resident of Ram Krishna Colony, Ward No. 47 of S.M.C. Near Bharti Hindi School, P.O. & P.S. Pradhan Nagar, Dist. Darjeeling, beg to report you the following facts:-

1. That Smt. Parvati Routh, Wife of Late Jagdish Routh is our Grand Mother.
2. That today i.e. 02.9.2025 at about 12.:45 p.m. when our sister in-law namely Priyanka Ray, Wife of Anurag Routh, and Smt. Rati Sharma, Wife of Raj Narayan Routh, went to feed our old aged grandmother at that time our elder uncle namely Sheyam Routh, Son of Late Jagadish Routh started abusing our sister's in-law in filthy and offensive languages finding the situation intolerable ladies of our house protested him and asking him as to why without any reason he scolded them at that time said Sheyam Routh became violent and started physically assaulted to those ladies of our house and with the help of his family members torn the wearing apparels of our two sisters in-law with the intention to disrobe them, any how those two ladies of our house fled away by freed themselves and came back to our house and narrated the whole incidents to us, hearing this my father Raju Routh and one uncle namely Rakesh Routh went to understand the matter at that time (i) **Sheyam Routh**, Son of Late Jagadish Routh, (ii) **Sujal Routh**, Son of Sheyam Routh, (iii) **Guriya Routh**, D/O. Sheyam Routh (iv) **Sapna Routh**, D/O. Sheyam Routh, (v) **Muskan Routh**, D/O. Sheyam Routh, (vi) **Nitika Routh**, D/O. Sheyam Routh, (vii) **Lucky**, husband of Muskan, (viii) **Husband of Nitika Routh**, seeing our father and uncle and without hearing anything from them started physically assaulted them mercilessly, they hit my father and uncle with iron rod, hearing the hue and cry of our father and uncle we the family members rushed to the

spot and tried to save our father's at that time all the above named miscreants assaulted all of us. They badly scratched my whole body and neck with their nail. They brutally assaulted my wife Smt. Arpita Routh, who is admitted in the Siliguri S.D. Hospital. All the above named miscreants out raged the modesty of my wife and torn the cloths of my wife and made her almost necked in front of whole family.

I, therefore, request you to kindly take necessary legal action against the aforesaid persons for the commission of the aforesaid offences by them upon me.
