I Bijay Yadav, S/O Lakeshwar Yadav of New Pokaijote, Ward no. 46, was returning home from my shop in Regulated Market area, Siliguri, but in the way (1) Shiv narayan yadav (bantha) s/o Lt shri Yadav (mandal) (2) Bikram Yadav s/o Shiv narayan Yadav (3) Chandan Yadav s/o Sri Gango Yadav (4) Shyam Yadav s/o Gango Yadav (5) suman Yadav s/o sri shiv narayan yadav (6) Umashankar yadav s/o shri kailash yadav (7) Indrakant yadav s/o shri kailash yadav (8) Pankaj Yadav s/o Umashankar Yadav (9) Nandkishor yadav s/o Umashankar Yadav (10) Binod yadav s/o leelo yadav (11) Rupesh yadav s/o leelo yadav attacked me to kill me and murder me with knife, iron rod and arms at around 9.00 pm near TC 2 stall of Regulated Market area, Siliguri, and I am now admitted in Siliguri District Hospital, with fractures in my skull and pain in my chest where the above mentioned culprits have attacked and attempted to murder me by complaining through this FIR with great pain.

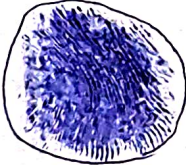
