Respected Sir,

I, Rupesh Kumar Yadav, son of Shri Lilo Yadav, resident of Regulated Market, Post Office - Pradhan Nagar, Police Station - Pradhan Nagar, would like to lodge this complaint.

That today (02.09.2025) at about 9:20 PM, when my father Lilo Yadav was going to his stall, suddenly Nand Lal Yadav, Raju Yadav, Jaykant Yadav, Bijay Yadav, Rajgir Yadav, Sevak Yadav, Sachin Yadav, Dipesh Yadav, Ankush Yadav, Ratan Dev Yadav, Avdesh Yadav, Surendra Yadav, Shayam Yadav, Kundan Yadav, Nitesh Yadav and others along with their goons wrongfully restrained him and attacked him with lathis and bamboo sticks on his head with the intention to kill him.

When people from the market rushed to save him, the said accused persons also attacked Shiv Narayan Yadav @ Bantha with lathi, iron rod, and other

sharp weapons, causing grievous injuries with the intention to kill him. They further attacked Ramblish Yadav with a sharp weapon/knife on his chest with the intent to murder him on the spot.

Thereafter, the said accused persons and their associates forcefully entered Stall No. TC-11, committed mischief and caused heavy damage to the stall, broke the almirah, and looted cash and property worth about ₹2,00,000/- (Two Lakhs only).

On receiving a call, the police arrived at the spot and rescued my father Lilo Yadav, Ramblish Yadav, and Bikram Yadav, along with Shiv Narayan Yadav, and admitted them to Siliguri District Hospital for treatment.

Therefore, I humbly request you to kindly take immediate and strict legal action against the above-named accused persons and their associates, register a proper case against them, and ensure that they are punished as per law so that such unlawful and violent incidents may not occur again in future.
