Siliguri, District- Darjeeling, would like to inform you that on 13/08/2025 at about are sons of Vijay Kumar Sharma (Dholu) and Madan Mohan Sharma (Mukesh), both of assassinate our family members and after opening the door they started quarrel with me and they misbehaved with me and my wife but at the same time they also assault me also, and unexpectedly said Madan Mohan Sharma and Purshottam Sharma (Dholu) started to assaulted them brutally by kicks and fists. As such they suffered several injuries at their program, which is held on 13/08/2025. Thereafter I informed about such incident to the councilor of the locality as well as the concerned Police Station.

Sir, on 29/08/2025 my wife and my son namely Vikash Kumar Sharma went to Delhi after knowing the said facts they again came on 31/08/2025 at about 10:15 P.M. in drunken condition and started to assault me as such I suffered several injuries at my forehead, chest and other part of body. They also snatched gold chain from my neck and fled away.

Sir they did this type of offences several times and several cases were also pending upon them. Sir Purshottam Sharma and Madan Mohan Sharma, both are Sons of Vijay Kumar Sharma are addicted person and they took ganja also.

Sir it is our apprehension that Purshottam Sharma and Madan Mohan Sharma may

take any illegal acts in drunken condition in future as they are habitual offenders. Our family members are now living in fear of their acts. The person of the society is also in the fear for their future illegal acts.

Therefore I requested you to investigate into the matter and to take legal action against those persons so that they would be punished as per law and thereby I shall be obliged to you.
