With due respect I, Kiran Mallick, Wife of Kameshwar Mallick, Daughter of Ashok Kumar Mallick, resident of Putimari, P.O & P.S: Bagdogra, Dist: Darjeeling, West Bengal 734014 begs to draw your kind notice that my marriage of solemnized with Kameshwar Mallick, Son of Late Panchkori Mallick, resident of Gowala Busty, Airport More, P.O & P.S: Bagdogra, Dist: Darjeeling on 24.02.2016 at my aforesaid place of residence under Hindu Rites and Customs. That soon after my marriage my husband Kameshwar Mallick and Mother-in-law Rampari Mallick started physically and mentally torture me with regard to my face and body complexion. That on my marriage my father gave all household goods viz. Bed, Almirah, Dressing Table, Alna, T.V along with household utensils as well as Rs. 2,00,000/- (Rupees Two Lakh) cash. That the aforesaid persons kept all my Stridhan and also cash amount with themselves soon after the marriage was over. Soon after my marriage the aforesaid persons started to torture me both physically and mentally. I was not allowed to enter the kitchen and cook any food for myself. Qut of our wedlock two female child was born on 29.09.2018 namely Utsavi Mallick and 27.03.2024 namely Ritika Mallick. During my pregnancy for the first child their behaviour with me was good but when I gave birth a girl child my husband instructed me to leave my daughter in nospital even he did not came to see my daughter. After 6 (Six) month when I return back to my matrimonial house they did not show their love to my daughter even my husband denied to bring baby food and other useful things for the baby as she was a girl child and my husband desired to have boy child. When I got pregnant for the second time my husband clearly worn me to give birth a male child otherwise I will not allowed you and the new born baby to my house. After birth of my second child the physical and mental torture grew even more. I was not provided with sufficient food for the
