Subject: Report regarding snatching

Respected Sir,

I, Binayak Mohapatra, aged about 38 years, son of Late Brajendra Narayan Mohapatra, residing at Punjabi Para, Siliguri, and working at Udaan group of companies, beg to lodge the following report: On 2nd of sept 2025, around 9pm, while I was returning from work in my car bearing registration number WB 74 AE 8221, suddenly two persons came in front of my car riding a bicycle from the wrong side of the road, right next to the zudio building at Beekay centrio located at Iskon more, Sevoke road. One of them started abusing me with filthy language, while another stood far away. I got out of my car and we had an exchange of words and then suddenly crowd gathered and taking advantage of the crowd, they person who abused me had snatched away my gold ring weighing about 10 grams and started running towards the one who was waiting at a distance with the bicycle. Although I chased them but could not catch them. I can identify both the persons. The first one, aged about 20-25 years, was speaking hindi and Bengali and was short height wearing a yellow t-shirt. The second one was tall height and was standing far with the bicycle.. After committing the offence, they abused me, threatened to kill me and immediately fled from the spot. The above incident has caused me serious fear and loss. Hence, I request you to kindly register my complaint, take necessary legal action against the culprits, and recover my stolen property.

Details of Stolen Article:

- One gold ring, approx. 10 grams. I am ready to provide further assistance in investigation and to identify the accused person.
