## Respected Sir,

I, Smt. Jasinta Kujur @ Oroan D/o Lt. Bhouka Oroan, resident of village Thiknivitta Basti, P.O Menghora, Dist. Jalpaiguri, belonging to poor tribal family and being simple cultivator with little knowledge of official or legal procedures, most respectfully submit the following complaint for your immediate attention. It has come to my knowledge only recently that deeds purporting to have been executed by — namely Bhouka Kujur @ Oraon, have been registered at the ADSR office, Rajganj, Dist. Jalpaiguri.

## Schedule of the Property

District Jalpaiguri, Mouza - Mantadri, Sheet No. 1, JL No. 6, LR Khatian No. 64, including Plot No. 176, 176/300, 178, 180, 181 and 182, land measuring- 4.52 acres in the name of Bhouka Kujur father of the complainant Jasinta Kujur

I, categorically deny ever selling or transferring any portion of our agricultural land to the above-named persons. Nor None of my family members have ever appeared in the ADSR office to execute or register such deeds, nor have we authorised any attorney or representative for the same.

I also place on record that I have no knowledge of the alleged purchasers and, in fact, have never even seen them. It appears that the deeds have been executed without my knowledge and by fraudulent means, suppression and manipulation of facts. Being poor tribal cultivator and not conversant with the technicalities of registration or mutation, I have been highly vulnerable to such fraudulent practices. My ignorance has been taken advantage of,
