SUBJECT: Complaint regarding tribal land illegally sold by some imposters — prayer for inquiry, and lodging FIR against the alleged purchaser Shymal Chikbaraik and Lina Chikbaraik.

Respected Sir,

I, Shri Biharu Oraon s/o Lt. Birsai Oraon, mother Lt. Malati Oraon resident of village Thiknivitta Basti, PO Menghora, Diust. Jalpaiguri, belonging to poor tribal family and being simple cultivator with little knowledge of official or legal procedures, most respectfully submit the following complaint for your immediate attention. It has come to my knowledge only recently that deeds purporting to have been executed by my family member — namely Malati Kujur, have been registered at the ADSR office, Rajganj, Dist. Jalpaiguri.

The details of such deeds are given below for ready reference:

I, categorically deny ever selling or transferring any portion of our agricultural land to the above-named persons. None of my family members have ever appeared in the ADSR office to execute or register such deeds, nor have we authorised any attorney or representative for the same.

I also place on record that I have no knowledge of the alleged purchasers and, in fact, have never even seen them. It appears that the deeds have been executed without our knowledge and by fraudulent suppression and manipulation of facts. Being poor tribal cultivators and not conversant with the technicalities of registration or mutation, my parents were highly vulnerable to such fraudulent practices. Our ignorance has been taken advantage of, and the transactions appear to have been carried out behind our back. The facts clearly demonstrate that the impugned transactions are fraudulent in nature, being the result of
