FIRST INFORMATION REPORT

It is to inform you that on 30.08.25, on a specific information a special MCP was laid near Toll Plaza Fulbari, and the special MCP party seized 01 heavy truck loaded with 20 no's Buffalos, 23 no's Buffalos Calves(Milk Feeding) On dated - 31st Aug 2025 at about 0930 hrs when the buffalo were handed over to Md Shah jahan, Vill-Amaidigi, PO-Fulbari, Dist - Jalpaiguri, (W. B) 07 buffalo calves were found dead. BSF then handed over 20 buffalo and 16 buffalo calves(out of 23) were handed over to concerned person. PQR under process.In very inhumane condition without valid documents for their transportation and also apprehended 08 Indian Nationals.
